TABLE 2 – SUMMARY OF ENVIRONMENTAL EFFECTS

The main aim of the Clackmannanshire Sustainability Strategy is to provide a framework to ensure that the Council is discharging its duty of Best Value in a way that contributes to sustainable development. The Strategy will incorporate indicators and targets which enable measurement of progress towards improved sustainability performance, and an Action Plan which provides details of projects which will deliver practical improvements and timescales for their implementation.

The Strategy seeks to influence other Council plans and strategies, and the actions of those outside the Council itself, in such a way that negative environmental effects will be reduced and positive environmental effects maximised. This can be brought about by actions such as promoting recycling, reducing energy waste, and encouraging less environmentally harmful means of travelling. In certain cases, proposals may lead to competing environmental costs or benefits and strategic environmental assessment will provide a tool to evaluate and measure the likely impacts in these cases, consider the least environmentally harmful course of action and consider the scope for mitigation.

The Strategy will have close links with other Council plans and strategies, some of which are subject to SEA. In these cases, consideration will be given to how the SEA process can be integrated and how aims and objectives can complement each other, providing scope for synergies in maximising sustainability and environmental performance, and eliminating or mitigating negative environmental effects where possible.
