1.0 Presentation by Richard Cooke, Convenor of the National	
Access Forum	
1.1 Richard explained that the National Access Forum (NAF) was established following the passing of the Land Reform (Scotland) Act 2003, that it does not have any statutory basis and that it was created to assist Scottish Natural Heritage publicise the Scottish Outdoor Access Code.	
1.2 He was elected as Convenor to the NAF in November 2008 and took-up the post in January 2009.	
1.3 Richard has considerable experience of access issues gained from his work as factor for Dalhousie Estate, liaison with Angus Council on the Brechin Footpath Network, from creating a Country Park at Brechin and from involvement in Deer	

Management Groups (Secretary of the East Grampian Deer	
Management Group from 1979-2005 and Secretary of the	
Association of Deer Management Groups from 1992).	
1.4 The NAF is an advisory body, with 25 full and 70	
corresponding members, but does not have any statutory powers,	
nor any budget. Its overarching aim is to facilitate enjoyment of	
the outdoors and to encourage responsible land management.	
1.5 The NAF has voiced concerns to MSPs that funding given to	
local authorities for access is not ring fenced.	
1.6 Richard said that he would like to see consistency and co-	
ordination on access matters.	
1.7 He would also like to see a Local Access Forum (LAF)	
network developed and better links between the NAF and LAFs.	
He highlighted the need for information and education on access	
legislation.	
1.8 There was some discussion over whether Paths For All (PFA)	
had any role in communication between Access Fora. Colin W	
stated that PFA's role is to promote good practice and that they	
had organised regional events for Local Access Fora in the past.	
He also commented that some LAFs had held joint meetings.	
1.9 Brian raised concerns that there weren't sanctions for	
irresponsible access takers. Richard commented that the Scottish	
Outdoor Access Code attempts to clarify what responsible access	
is, that education is essential in tackling irresponsible access and	
that LAFs can provide advice on local issues.	
1.10 Linda referred to inconsistencies between access legislation	
and other legislation affecting equestrian users. Richard	
commented that he didn't believe that access rights of equestrian

users should be compromised because of technicalities and that	
progress in dealing with such inconsistencies could be made by	
better communication and consensus.	
1.11 David asked what measures were being taken to address	
irresponsible wild camping. Richard referred to good practice in	
the Loch Lomond and Trossachs National Park where	
partnership working involving police, rangers and others had	
made some progress in tackling the issue.

8.0 Tillicoultry Glen bridge advice	
8.1 Martin thanked the Forum for the advice that it gave on the Tillicoultry Glen bridge. This was that the bridge should be repaired, with stepping stones a second option.	
8.2 Martin also brought the advice from Friends Of The Ochils to the attention of members of the Forum. This was included in a document on Access/Walking routes for the OLP (Ochils Landscape Partnership). Their advice was to install another small, unobstrusive bridge along similar lines to the existing one. They also stated that "we think it would be inappropriate to improve the paths approaching either side of the Gannel Burn, as to do so could entice non-hillwalkers inappropriately onto what is in fact an extremely steep and potentially slippery stretch of path	
 up The Law." 8.3 It was noted that some works to the bridge might be possible as part of the Ochils Landscape Partnership project. 	
9.0 Locked gates	
9.1 Gordon had raised the issue of locked gates on the west side of Silver Glen at the last meeting.	
9.2 Both Martin and Alistair have visited the gates. All are	
padlocked and topped with barbed wire, and have adjacent stiles which provide access for pedestrians, but not for pedestrians with limited mobility, nor for other users such as horse riders.	
9.3 Martin has also met with the farmer and been advised that the gates are padlocked because they have been left open in the past and that this has allowed farm animals to move from one field to another and caused associated problems.	
9.4 Martin further advised that the farmer was accepting of self closing gates being installed (by the Council) to replace the stiles.	
9.5 He also highlighted that Wind Prospect are wanting to run the cable from Burnfoot Hill Wind Farm to Fishcross via the track and, should this happen; it could impact on any newly installed self closing gates.	
9.6 There followed lengthy discussion about the adequacy of stiles in such situations, with some, but not all; feeling that they were a barrier for some access takers.	
9.7 It was agreed to await the outcome of Wind Prospects planning application to run a cable down the track, prior to making a final decision on the matter.	

10.0 Any other business	
10.1 Linda brought to the attention of the Forum 2 holes that have appeared on the Devonway at Blackfaulds and Marchglen. It was agreed that Euan would visit the path and arrange for any
