5.0 LEP Update on Employability and Business Growth workstream

- 5.1 Zak Stark reported that the Local Employability Partnership has created a sub-group to look at employer engagement.
- 5.2 The Employer Support Toolkit on Clacksweb is being updated and now includes an interactive component. The link will be circulated and the 'hit' count will be recorded. Up-to-date FSB and Business Gateway contacts will be forwarded for inclusion. It was noted that it is now possible to include the Chamber of Commerce. Visit Scotland and Business Gateway will take steps to establish a working link. Wider sectoral representation in the matrix was noted as a possible development for the future.

8.0 Longannet Closure

- 8.1 Partners are represented on the Task Force set up ahead of the plant closing on the 1st of April 2016 to devise an economic recovery plan in light of the expected negative impact on Clackmannanshire's employment levels, local contractors, local spending and the supply chain generally. As well as welfare and business support elements, the Task Force will also look at the long-term opportunities for the site.
- 8.2 Scottish Enterprise has contributed towards the employment costs of a dedicated Task Force Adviser for the Longannet closure. The Task Force is due to meet again in February 2016 to consider a finalised plan.
