| <b><u>1.3 Report on the work and achievements of the Forum</u></b>                             |        |

"2015 was another busy year for the Clackmannanshire Access Forum.

The Forum met on 3 occasions after last years AGM - in May, September and December. It also held site visits to Fishcross in September and attended a Public meeting on the subject of Access Rights within the area of Fishcross.

At last years AGM, Brian Poett stood down but was re-elected to the Land Managers Group. 3 new members were elected to the Forum - John Hutcheson and Barbara Maddox were elected to the Users Group, and Alison Fox was elected to the Communities Group. 3 vacancies exist in the Agency and advisory group. Dick Clark was elected as Chair.

The Forum has become very aware of the changing use of the countryside and how the Core Path Network is being accessed by ALL authorised users and contributing to the well being and connection to Communities within the County. This has contributed to an increase of groups enjoying the diverseness of the area with advantages to a greater understanding of it being understood. We will continue to maintain as a Forum on the ever changing need by consensus in advising the Council on matters of Access with an emphasis of fairness to all users and respect of ownership of land.

The Forum advised the Council on signage relating to deer movements on core path 138 at Harviestoun and on addressing sign duplication in the Hillfoots. Advice has also been given on dealing with problems of unauthorised motorbike activity and on updating the **Forum's Partnership Agreement**.

The Forum has been provided with information on a variety of access matters, including:

- Ochils Landscape Partnership which finished in November and delivered 22 different projects in the Hillfoots area, some of which will benefit access. EPIC (Enabling Projects in Clackmannanshire) has recently been created and will maintain the OLP projects for 10 years.
- Inner Forth Landscape Initiative which will deliver 4 access projects in Clackmannanshire. Works are currently taking place on the Walk to the Wetland and the Cambus Whisky and Wetland Wander projects.
- Inner Forth Landscape Initiative trainees who have undertaken improvement works to a number of paths bordering the Forth.
