### Clackmannanshire Council

There are 32 Unitary Councils in Scotland. Clackmannanshire Council is the smallest mainland Council. Eighteen Councillors are elected to represent the views of the residents and businesses in Clackmannanshire. The Council has approved Standing Orders that detail the way the Council operates. Decisions are approved at the 9 weekly meetings of the full Council and at Committee Meetings.

The Council is responsible for approving a staffing structure for the proper discharge of its functions, approving new policies or changes in policy, community planning and corporate governance including standards of conduct.

The Council has further responsibility for the approval of budgets for capital and revenue expenditure, it also has power to make, alter or cancel any scheme made under statute and to make, alter or cancel any orders, rules, regulations or bye-laws and to make compulsory purchase orders. The Council also determines the level of Council Tax and approves recommendations relating to strategic economic development.

Members of the public are welcome to attend our Council and Committee meetings to see how decisions are made.

Subject Refugee Crisis & Syrian Resettlement Scheme - Request for Information

Sent to: Chief Executives; Leaders and Conveners of Admin; Presidential Team Dear Colleagues,

Since last week we have received a great deal of interest from member councils interested in receiving refugees who have been caught up in the current crisis. The Scottish Government will hold the first meeting of the task group announced at the First Minister's Summit tomorrow afternoon. The Prime Minister has also just announced that the UK will receive up to 20,000 refugees from the crisis, and the First Minister has already indicated that Scotland will take 10% of the total number resettled in the UK. In order to inform our negotiations with both the Scottish Government and the Home Office I would appreciate it if you could let me know by 2pm tomorrow [Tuesday 8 September]:

- 1. Whether your council is actively considering becoming involved in resettling refugees affected by the current crisis; and if so
- 2. Can you provide us with an early indication of how many people you may be able to accommodate?

This information will allow us to effectively represent our member councils and negotiate to ensure that the local government response is adequately resourced. Information provided to us at this stage will not be shared and will only be used to provide an indication of the likely capacity of Scottish local government to respond to the crisis. Given the fluidity of the situation we recognise that your capacity may go up or down as things develop, and that it may indeed be influenced by what resources Scottish Government and the Home Office can make available.

If you do decide to receive resettled refugees into your area we will work with you to ensure that you receive the support you need to make this work both for the council and for the people who come to live in your area.

I apologise for the very tight deadline. This is necessary because of the very short notice that Scottish Government have given us regarding the first meeting of the task group.

We will keep you up to date as discussions progress.

Sent to: Chief Executives; Leaders and Conveners of Admin; Presidential Team Dear colleagues,

There has been a great deal of interest from councils in relation to the Summit on the refugee crisis that the First Minister hosted this afternoon and we just wish to give you an early update on the discussions that took place. A few bullet points below:

- COSLA Community Wellbeing Spokesperson Harry McGuigan attended and spoke about the crucial role of UK, Scottish and local government in tackling the crisis in a coordinated manner. He also discussed the role that local authorities are playing, and are seeking to play going forward, to support the humanitarian effort.
- The First Minister indicated that she wished to do intensive work with local authorities, and other partners in the statutory and voluntary sector, to identify the capacity that exists in Scotland and we are seeking to clarify what this might mean in practice. Capacity is of course difficult to ascertain when we don't yet have a sense of the approach that the UK Government is hoping to take or the level of funding that will be made available to support councils and their partners, whether from the UK or Scottish Government. However, the First Minister did say that the Scottish Government will be providing financial and practical support to local authorities that are able to participate.
- The Scottish Government now intend to convene a task force to look at the issues in more detail and will also be writing to the UK Government to outline the partnership approach that they would wish to take in Scotland.
- Cllr McGuigan will be contacting the First Minister to clarify the points he made at the meeting and the importance of local, Scottish and UK government meeting to discuss the role that the different spheres of government will play. He will also be discussing the crisis at the Community Wellbeing Executive Group that he chairs and which takes place on next Friday.
- We will seek to keep councils informed of any developments in the coming days and weeks. In the meantime, we would be happy to provide you with information with respect to the current Syrian Vulnerable Persons Relocation Scheme. We have worked with a number of councils that have expressed interest in the scheme since it was first announced in February 2014 and will continue to provide information to support councils in that regard.
