Having heard representations from the Applicant's Solicitor, Mr Thomson, Sergeant Marie White (on behalf of the Chief Constable) and taking into account the Licensing Standards Officer's report dated 24 April 2017 and his representation, that the Board grants the application for four occasional licences subject to the conditions set out at Page 4 of the Licensing Standards Officer's report dated 24 April 2017.

Decision

Having heard representations from the Applicant's Solicitor, Mr Thomson, Sergeant Marie White (on behalf of the Chief Constable) and taking into account the Licensing Standards Officer's report dated 24 April 2017 and his representation, the Board, on a division of 4 votes to 0 with 1 abstention, agreed to grant the four applications subject to the conditions set out at Page 4 of the Licensing Standards Officer's report dated 24 April 2017, namely:

- 1. The Licence holder or another suitably qualified Personal Licence Holder must be present on the premises during all hours at which alcohol is available for sale, said personal licence holder must be responsible for authorising all sales of alcohol.
- 2. Alcohol on the premises must only be displayed for sale in the area identified on the plan which accompanied the applications. A copy of this plan will be endorsed as approved by the Licensing Board and must be kept on the premises along with the occasional licence.
