Circumstances leading to Hearing

1. Notice of conviction of a relevant offence in terms of Section 82(3) of the 2005 Act was received by Clackmannanshire Licensing Board on 03 May 2018 A copy of said Notice is attached.

The Hearing

At the Hearing, the Board will have regard to the conviction and the Chief Constable's representative and you, the Personal Licence Holder, will be given an opportunity to be heard.

Section 83(9) Order

If the Board is satisfied that it is necessary to do so for the purposes of one or more of the licensing objectives it may make an order revoking, suspending or endorsing your Personal Licence. The maximum period of suspension which can be imposed is 6 months.

You are advised that it is in your best interests to appear at this hearing. You may be represented by a solicitor or any another person.
