RC.120 MINUTES OF MEETING: REGULATORY COMMITTEE 26 JANUARY 2016

## RC.121 TAXI OPERATOR LICENCES

A report was submitted by the Head of Development and Environment which considered the conclusions and recommendations contained within the Significant Unmet Demand Report, commissioned to establish if there is a need to set a limit on the number of taxi operator licences issued by Clackmannanshire Council.

The power to set an upper limit on taxi operators is contained within Section 10(3) of the Civic Government (Scotland) Act 1982 which provides licensing authorities with the power to set an upper limit for taxi operator licenses only after it is satisfied that there is no significant unmet demand for the services of a taxi.

That Committee agrees the recommendations set out in the report.

#### **Amendment**

That Committee agrees the paper subject to amendment at paragraph 2.1, that Committee agrees to the introduction of an upper limit on the number of taxis and agrees to set an upper limit of 55 for taxi operator licences issued by Clackmannanshire Council.

## Voting

The amendment was carried unanimously by 8 votes to 0.

# Decision

The motion as amended was agreed without division (8 votes for). Accordingly, the Committee agreed unanimously:

- (1) to the introduction of an upper limit on the number of taxis to be set at 55 for taxi operator licences issued by Clackmannanshire Council.
- (2) to carry out cyclical "significant unmet demand" surveys in accordance with Scottish Government best practice guidance, the occurrence of which will be on a 5 year cycle or at such time as is deemed appropriate by the Committee.
- that the desired number of wheelchair accessible taxi vehicles licensed be no less than 10% of the total number of operator licences issued.
- (4) to increase taxi operator fees from 1 April 2016 to cover the cost of the current and future Significant Unmet Demand surveys.
- to actions to progress the further recommendations as set out in paragraphs 4.4 to 4.8 of the report regarding disability awareness training for drivers, taxi and private hire car livery, taxi rank markings and signage and peaks in demand for taxi services.
