RC.131 FEES AND CHARGES

A report was submitted by the Head of Development and Environment the purpose of which was to ensure the best provision of short term Civic Government (Scotland) Act 1982 licences are available in Clackmannanshire and to set out how the expenditure incurred on the recent Unmet Demand Survey will be recovered. The report made recommendation to Committee.
