ESL(14)79 EDUCATION SERVICES QUARTER 4 PERFORMANCE 2013/14 PROGRESS REPORT

ESL(14)81 COST OF INCREASED EARLY LEARNING AND CHILDCARE ENTITLEMENT TO 600 HOURS

A report which provided the Committee the cost of implementing the first phase of the 600 hours of early learning and childcare entitlement for all 3 and 4 year old children from August 2014 was submitted by the Head of Education.

The report outlines the details of the funds provided by Scottish Government to Clackmannanshire Council for the purpose of local implementation of 600 hours of early learning and childcare.

- (2) agree the model and notes the costs associated with implementing the locally agreed model of delivery.
- (3) approve further work be undertaken to develop a more flexible model of delivery of 600 hours early learning and childcare for all 3 and 4 year olds as well as Looked After 2 year olds beyond August 2015 and within available resources.
