1.0 Purpose

1.1. The purpose of this report is to advise the Committee of the progress made on the displaying of public art at Fairfield pavilion.

- 3.1. A paper was presented to Education, Sport and Leisure Committee on June 19th, 2014 with regard to art work at Fairfield pavilion. Petitions had been received both for and against the current art work. The service was tasked to identify a practical solution.
- 3.2. It was agreed that the current art work was not determined through a robust process and that this should now be applied.
- 3.3. A letter was sent to all 150 petitioners in January 2015 outlining a proposal to engage the wider community in agreeing a piece of art work that would replace the existing one. Of the responses, only 3 expressed negativity towards the idea.
- 3.4. The Service will now remove the current art work and replace it with a piece agreed by a consultation process. (See appendix 1).
- 3.5. The current timeline is on schedule and due for completion by the end of July 2015.
