- 5. Endorse the utilisation of the full amount of Tranche 2 DWP DHP funding and recommend to Council, authorisation of expenditure of up to £156k for the mitigation of welfare reform in line with Financial Regulations and the Council's current DHP policy,
- 6. Note the underspend in General Services capital of £2.581m of which £0.489m are savings in delivery of programme with remainder carried forward to 2016/17; and
- 7. Note the underspend on HRA capital of £2.296m of which £1.311m are savings in delivery of programme with the remainder carried forward to 2016/17.
