

(VARIOUS STREETS, CLACKMANNAN) (20 MPH SPEED LIMIT) (AMENDMENT NO.1) ORDER 2013

Clackmannanshire Council, in exercise of the powers conferred upon it by Section 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Order may be cited as "The Clackmannanshire Council (Various Streets, Clackmannan) (20 mph Speed Limit) (Amendment No.1) Order 2013" and shall come into operation on the 22 November 2013.
- (2) This Order amends the Clackmannanshire Council (Various Streets, Clackmannan)
 (20 Speed Limit) Order 2011 by adding to the Schedule to that order, the additional lengths of road as detailed in the Schedule to this Amendment Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (4) A speed limit of 20 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the said lengths of roads.
- (5) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

The Council proposes to make the above Order under Section 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 which amends the Clackmannanshire Council (Various Streets, Clackmannan) (20 MPH Speed Limit) Order 2011 by adding additional lengths of roads. This will designate the roads in Clackmannan: Alexander Court, Blackwood Court, Brucefield Crescent, Burnside Crescent, Cherryton Drive, Duke Street, Erskine Place, Hetherington Drive, Kerse Green Road, Kirk Wynd, Ladywood, Mannan Drive, Marquis Drive, Mary Place, Mayfield Crescent, Mercat Place, Mill Road, Northfield Gardens, Park Place, St Serf's Grove, Tower Place and Woodside Terrace as a 20 miles per hour speed limit to ensure that traffic speeds are limited to a speed compatible with the local environment.
