

(VARIOUS STREETS, ALLOA) (TEMPORARY CLOSURE) ORDER 2013

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Closure) Order 2013" and notwithstanding the date hereof shall come into operation on the 10th November 2013.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 1000 hours on Sunday 10th November 2013 until 1230 hours on Sunday 10th November 2013 the section described in the Schedule attached. The temporary closure is required to facilitate a Remembrance Day Parade and for the safety of participants and members of the public. Pedestrian access will be maintained.
