(HIGH STREET AND MILL STREET, ALLOA) (TEMPORARY CLOSURE AND TEMPORARY REVERSAL OF ONE WAY TRAFFIC) ORDER 2013

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (High Street and Mill Street, Alloa) (Temporary Closure and Temporary Reversal of One Way Traffic) Order 2013" and notwithstanding the date hereof shall come into operation on the 14th December 2013.
- 2. The effect of this Order shall be to:

Close to vehicles the period from 1100 hours until 1330 hours on Saturday 14th December 2013 the section described in the Schedule 1 attached and to reverse the one way traffic system during the period from 0900 hours until 1330 hours on Saturday 14th December 2013 on the section described in the Schedule 2. The temporary closure and temporary reversal of one way is required for Reindeer Sleigh Rides and Christmas Train and to allow access for taxis and loading only during the Reindeer Sleigh Rides and Christmas Train.

The Council has made "The Clackmannanshire Council (High Street and Mill Street, Alloa) (Temporary Closure and Temporary Reversal of One Way Traffic) Order 2013", under the Road Traffic Regulation Act 1984 (as amended) on 4th November 2013 to close to vehicles: High Street, Alloa in its entirety (Alternative Route: None available - access for residents will be maintained) and to reverse the one-way traffic system for vehicles: From its junction with Bank Street north eastwards until its junction with Shillinghill, for a distance of 122 metres or thereby. The order runs from 1100 hours until 1330 hours on 14th December 2013 and is required for Reindeer Sleigh Rides and Christmas Train and from 0900 hours until 1330 hours on 14th December 2013 to allow access for taxis and loading only during the Reindeer Sleigh Rides and Christmas Train.
