The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C99 Marchglen) (Temporary Closure) Order 2013" and notwithstanding the date hereof shall come into operation on the 25th November 2013.
2. The effect of this Order shall be to close to vehicles:-  
The period from 0700 hours on Monday, 25th November 2013 until 1700 hours on Friday, 13th December 2013 on the section described in the Schedule attached. The temporary closure is required for reconstruction of the bridge parapet and to carry out parapet protection works on the east side of the road.

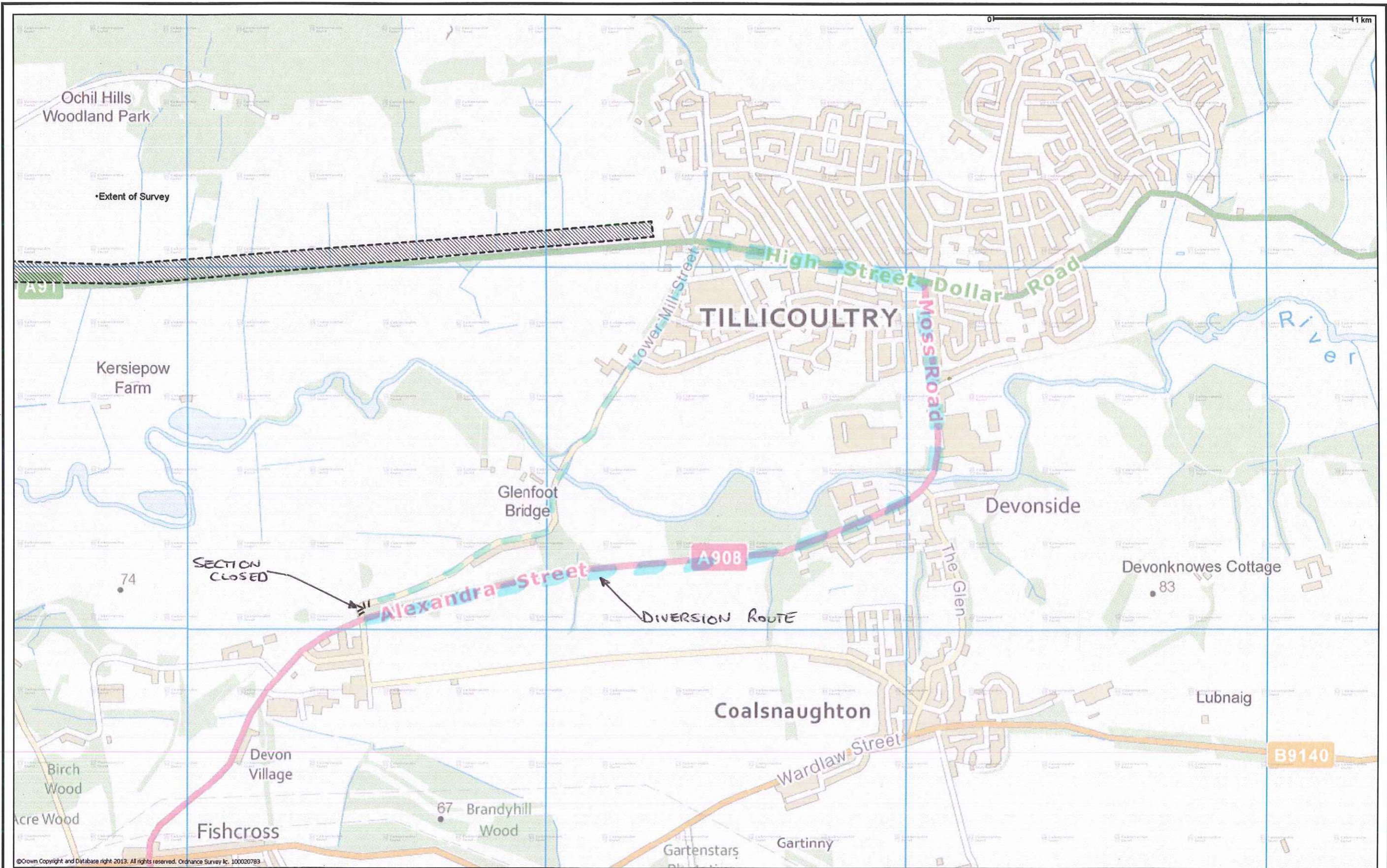
