The period from 0700 hours on Monday, 3rd March 2014 until 1700 hours on Friday, 14th March 2014 or until repairs are complete on the section described in the Schedule attached. The temporary road closure is required in order to facilitate repairs to bridge reference U080150-10 (at Burnside Farm Road/Silverburn Gardens junction).
