

(MANOR HOUSE ROAD, DOLLAR) (TEMPORARY ROAD CLOSURE) ORDER 2014

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Manor House Road, Dollar) (Temporary Road Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 17th March 2014.
- The effect of this Order shall be to close to vehicles:-The period from 0600 hours on Monday, 17th March 2014 until 2359 hours on Friday, 21st March 2014 on the section described in the Schedule attached. The temporary road closure is required to carry out replacement gas mains works.

The order runs from 0600 hours on Monday 17th March 2014 until 2359 hours on Friday 21st March 2014 and is required to carry out replacement gas mains works.
