1. This Order may be cited as "The Clackmannanshire Council (Cattlemarket, Clackmannan) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 30th June 2014.

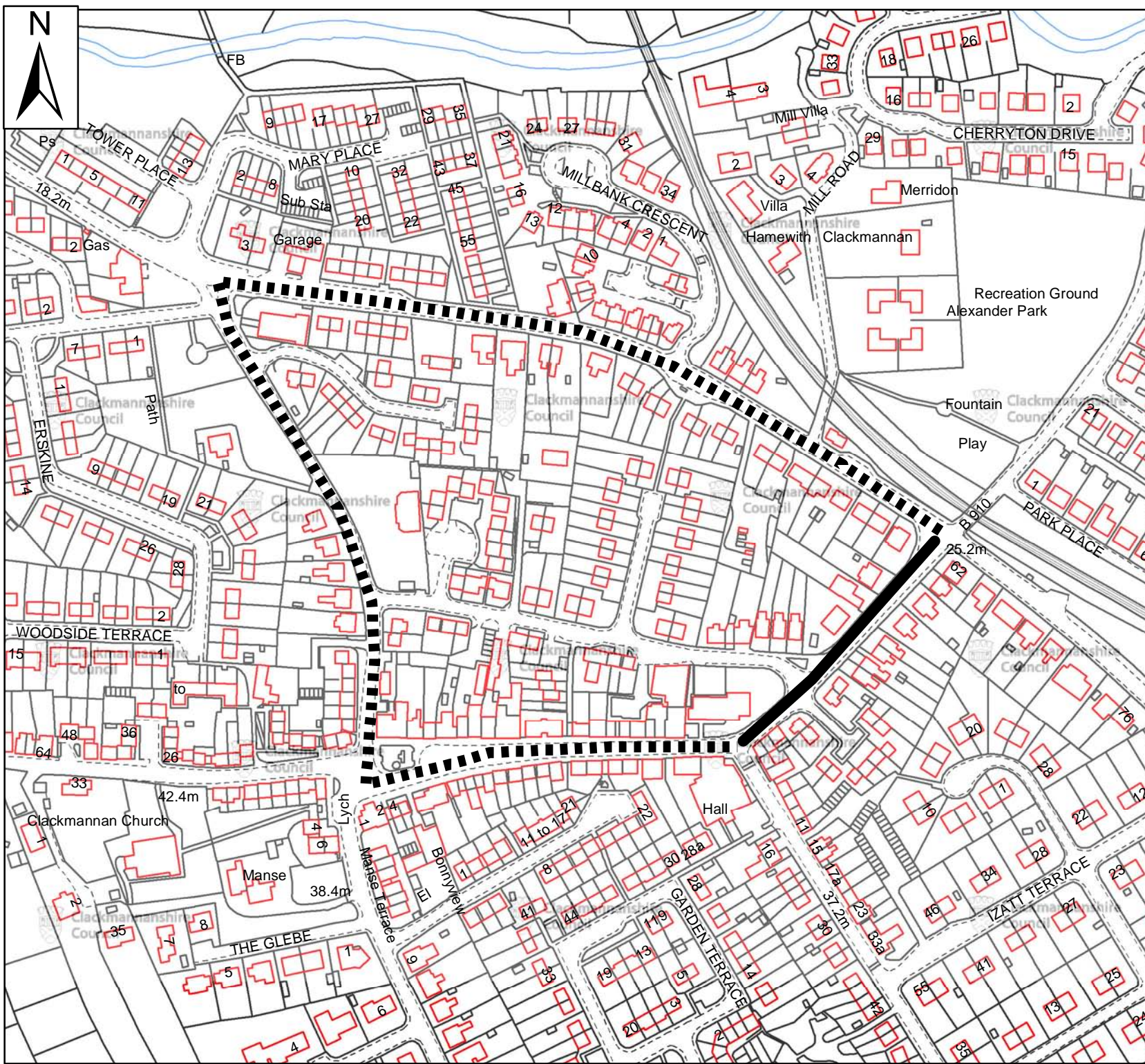
