1. This Order may be cited as "The Clackmannanshire Council (Kirk Wynd, Clackmannan) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 7th July 2014.
2. The effect of this Order shall be to close to vehicles:-  
The period from 0800 hours on Monday 7th July 2014 until 1700 hours on Sunday 13th July 2014 on the section described in the Schedule attached. The temporary closure is required for resurfacing works.

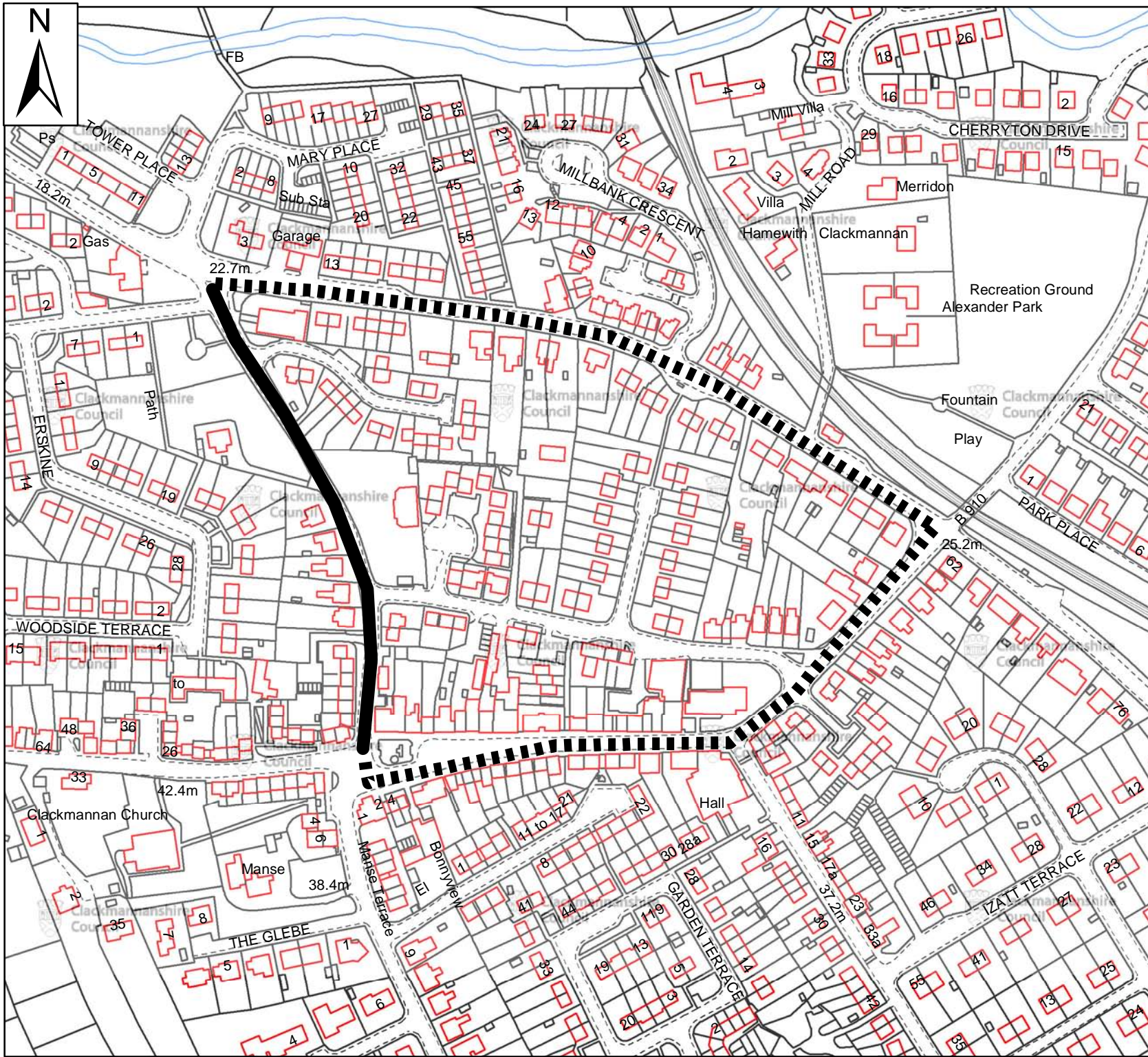
