



**(HILL STREET, ALLOA)
(TEMPORARY CLOSURE) ORDER 2014**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Hill Street, Alloa) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 14th July 2014.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 14th July 2014 until 1700 hours on Sunday 20th July 2014 on the section described in the Schedule attached. The temporary closure is required for resurfacing works.

(Diversion: Via Sunnyside Road, Ashley Terrace, Hill Street and vice versa). The order runs from 0800 hours on Monday 14th July 2014 until 1700 hours on Sunday 20th July 2014 and is required for resurfacing works. 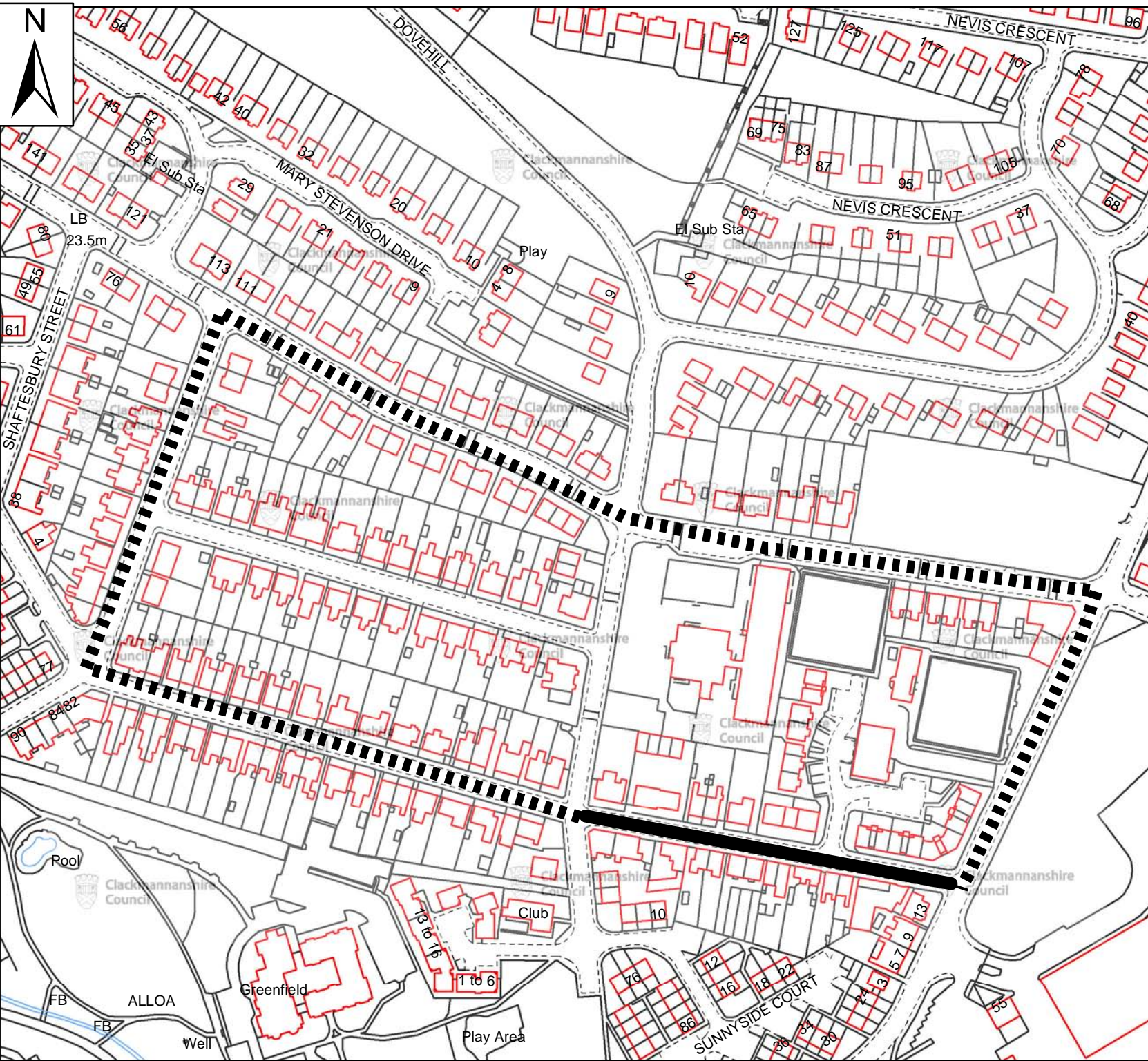
