

# (A91 TILLICOULTRY TO ALVA) (TEMPORARY SPEED RESTRICTION) ORDER 2014

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (A91 Tillicoultry to Alva) (Temporary Speed Restriction) Order 2014" and notwithstanding the date hereof shall come into operation on the 30th June 2014.
- 2. The effect of this Order shall be to restrict speeding of 30mph to vehicles:-The period from 1200 hours on Monday 30th June 2014 for 16 weeks or until TRO is complete on the section described in the Schedule attached. The temporary speed restriction is necessary to restrict the speed of traffic to allow the works on the cycle path to be complete and until the amendment to the TRO has been made.
