

(A907 STIRLING ROAD, ALLOA) (TEMPORARY 20MPH LIMIT) ORDER 2014

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (A907 Stirling Road, Alloa) (Temporary 20mph Limit) Order 2014" and notwithstanding the date hereof shall come into operation on the 20th August 2014.
- 2. The effect of this Order shall be to close to vehicles:-

For a period of 12 weeks from 0001 hours on Wednesday 20th August 2014 on the section described in the Schedule attached. The temporary 20mph limit is required as speed restrictions are being amended to ensure that the traffic speeds are limited to a speed compatible with the local environment.
