



**(A907 CLACKMANNAN ROAD, ALLOA)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Waiting Restrictions) Order 2014" and notwithstanding the date hereof shall come into operation on the 30th August 2014.
  
2. The effect of this Order shall be that there will be no waiting at any time during:-  
 The period from 1100 hours until 1800 hours on the following match days:: Saturday 30th August 2014, Saturday 20th September 2014, Saturday 11th October 2014, and Saturday 18th October 2014 on the section described in the Schedule attached. The temporary "no waiting restrictions" are necessary to facilitate flow of traffic before, during and after football matches at Alloa Athletic home ground Recreation Park, Alloa.

The Council has made "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Waiting Restriction) Order 2014", under the Road Traffic Regulation Act 1984 (as amended) on 13th August 2014: to close to vehicles at A907 Clackmannan Road, Alloa (North Side) from its junction with Shillinghill Roundabout eastwards for a distance of 82 metres or thereby, and from its junction with Balfour Street eastwards until its junction with Morrisons Roundabout, a distance of 650 metres or thereby, and (South Side) from its junction with Shillinghill Roundabout eastwards until its junction with Morrisons Roundabout, a distance of 930 metres or thereby. The order runs from 1100 hours until 1800 hours on the following match days: Saturday 30th August 2014, Saturday 20th September 2014, Saturday 11th October 2014, and Saturday 18th October 2014. The temporary "no waiting restrictions" are necessary to facilitate flow of traffic before, during and after football matches at Alloa Athletic home ground Recreation Park, Alloa. 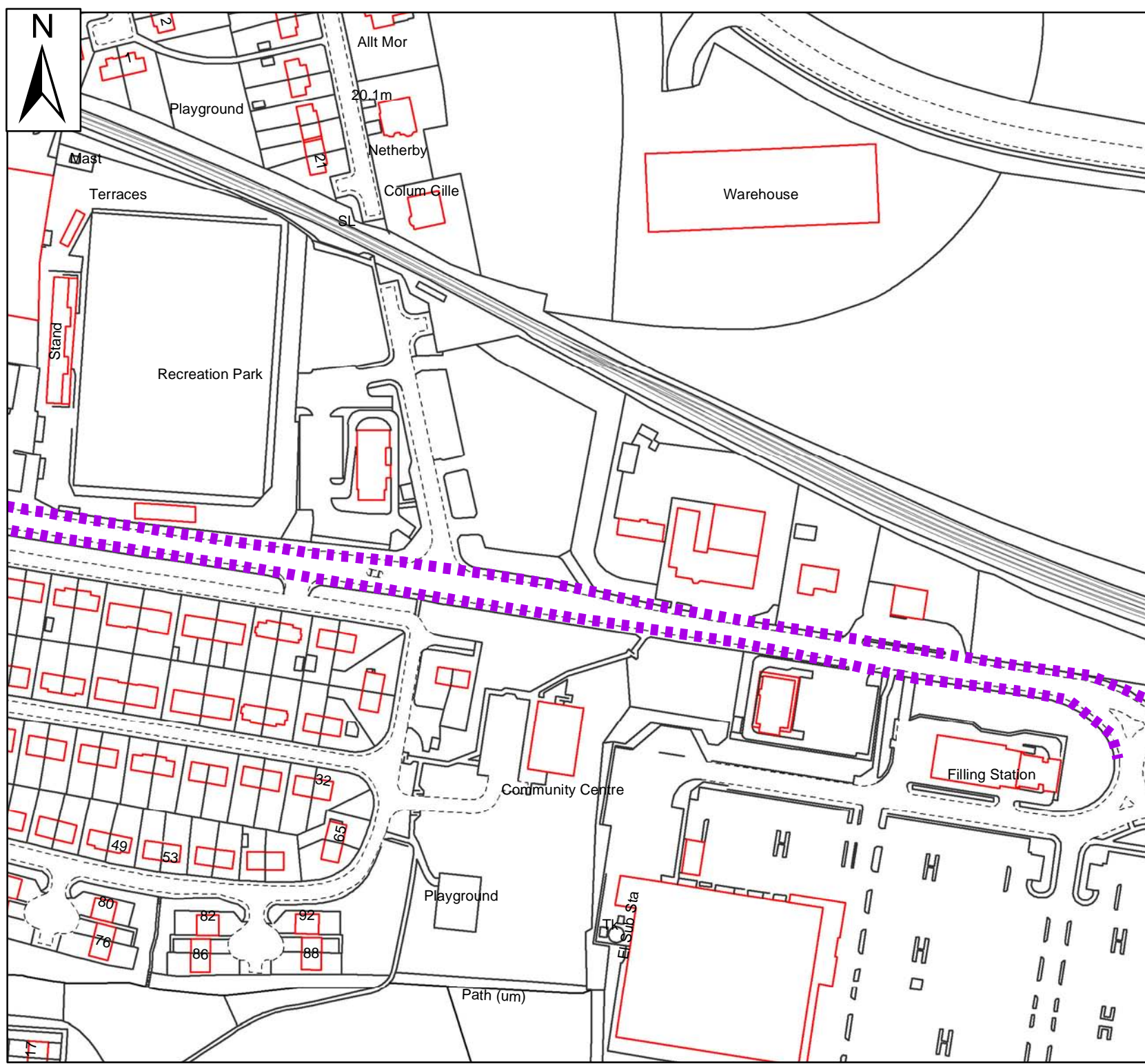

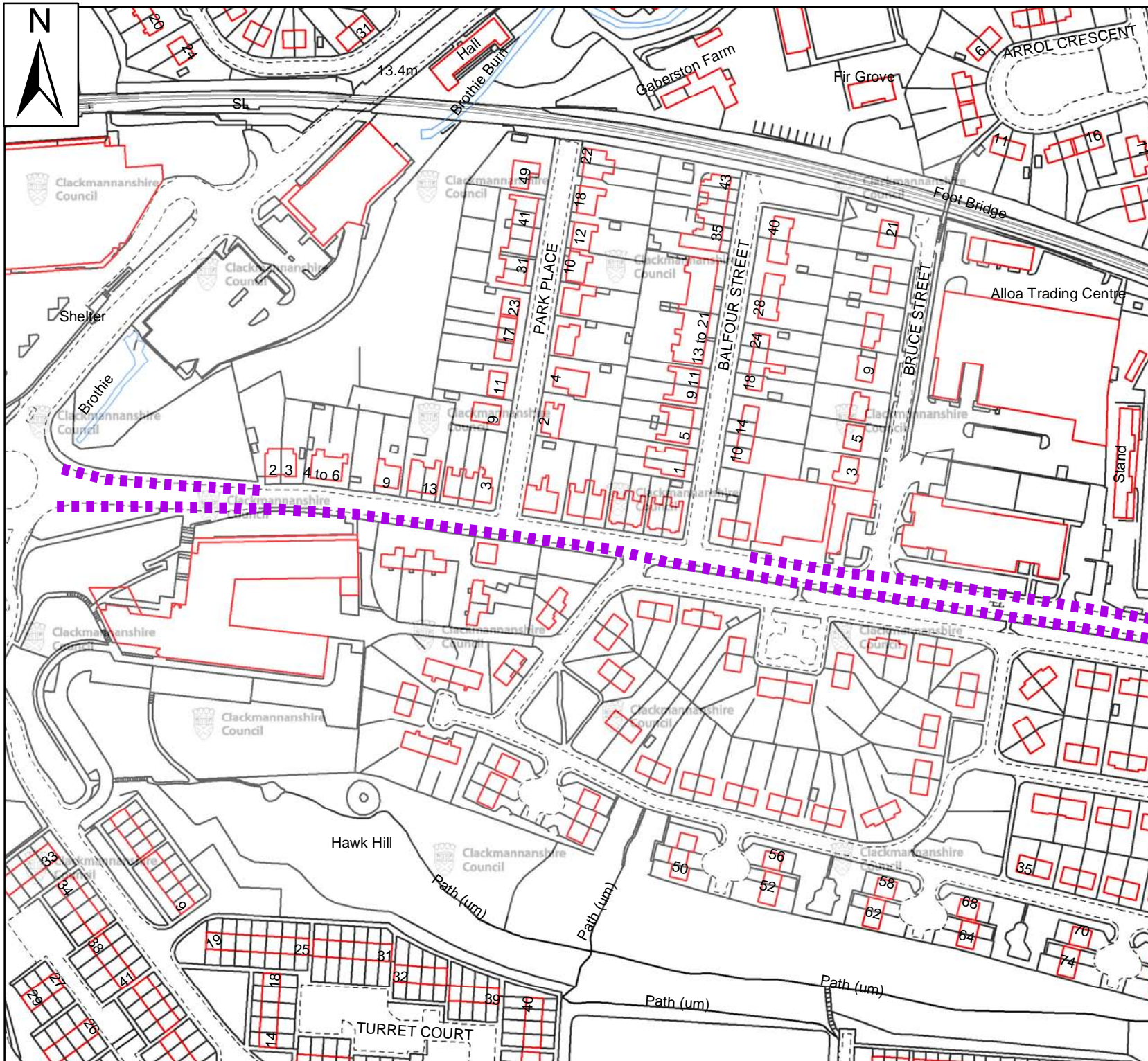
