

(C101 MENSTRIE-TULLIBODY) (TEMPORARY CLOSURE) ORDER 2014

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (C101 Menstrie-Tullibody) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 8th September 2014.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 8th September 2014 until 1700 hours on Sunday 21st September 2014 on the section described in the Schedule attached. The temporary closure is required for resurfacing works to take place.

The Council has made "The Clackmannanshire Council (C101 Menstrie-Tullibody) (Temporary Closure) Order 2014", under the Road Traffic Regulation Act 1984 (as amended) on 21st August 2014: to close to vehicles at C101 Menstrie-Tullibody from a point 140 metres south of its junction with A91 Main Street East, southwards for a distance of 375 metres or thereby. (Diversion Route: Via A91, C110, B9140 and vice versa). Residents will still have access to Middleton from Muirside Roundabout. Broompark East residents can access from A91 junction.
