



**(PARKWAY AND SUNNYSIDE ROAD, ALLOA)  
(TEMPORARY CLOSURE) ORDER 2014**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Parkway and Sunnyside Road, Alloa) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 8th September 2014.
2. The effect of this Order shall be to close to vehicles:-  
The period from 0800 hours on Monday 8th September 2014 until 1700 hours on Sunday 21st September 2014 on the section described in the Schedule attached. The temporary closure is required for resurfacing works to take place.

The Council has made "The Clackmannanshire Council (Parkway and Sunnyside Road, Alloa) (Temporary Closure) Order 2014", under the Road Traffic Regulation Act 1984 (as amended) on 18th August 2014: to close to vehicles at Parkway and Sunnyside Road, Alloa: (Parkway, Alloa) from its junction with B9096 Mar Place to its junction with Sunnyside Court, a distance of 175 metres or thereby, and (Sunnyside Road, Alloa) from its junction with Sunnyside Court until its junction with Hill Street, a distance of 227 metres or thereby. (Diversion Route: Via B9096, A907 Ring Road, A908 Whins Road, A908 Hallpark, Fairfield, Sunnyside Road and vice versa). (Diversion for Oversized HGVs: Via B9096, A907 Ring Road, A907 Clackmannan Road, AELR, A908 Hallpark, Fairfield, Sunnyside Road and vice versa). Access will be maintained to Alloa Leisure Bowl from Mar Place only. Access to Sunnyside Court will be from either B9096 or from Sunnyside Road depending on works. The order runs from 0800 hours on Monday 8th September 2014 until 1700 hours on Sunday 21st September 2014 and is required for resurfacing works to take place. 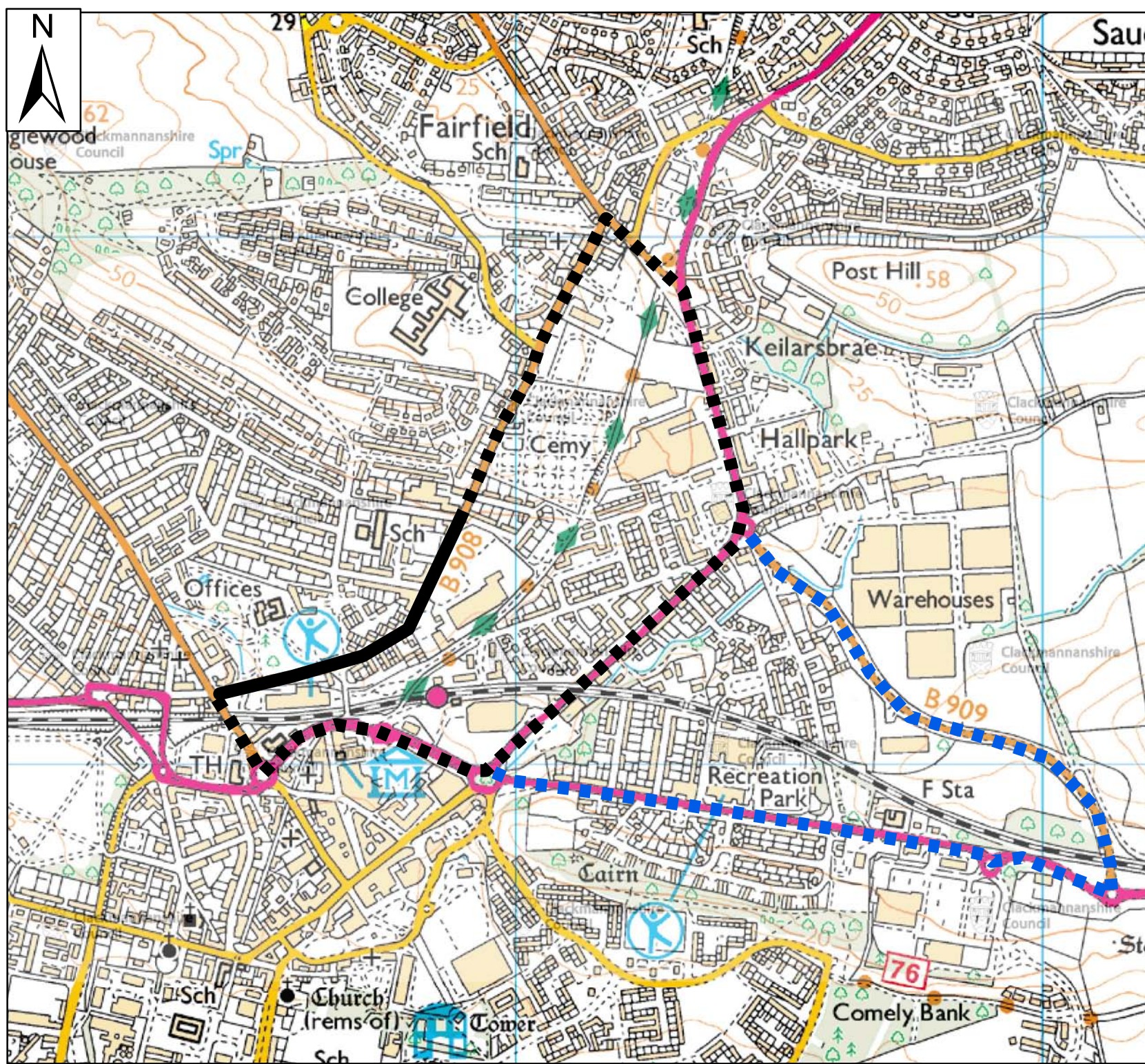
