**(MARSHILL, ALLOA)
(TEMPORARY CLOSURE) ORDER 2014**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Marshall, Alloa) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 18th September 2014.
2. The effect of this Order shall be to close to vehicles:-
The period from 2100 hours until 2400 hours on Thursday 18th September 2014 on the section described in the Schedule attached. The temporary closure is required for the Scottish Independence Referendum, to allow staff to off-load ballot boxes at the main door.

The Clackmannanshire Council (Marshall, Alloa) (Temporary Closure) Order 2014

The Council has made "The Clackmannanshire Council (Marshall, Alloa) (Temporary Closure) Order 2014", under the Road Traffic Regulation Act 1984 (as amended) on 29th August 2014: to close to vehicles at Marshall, Alloa from its junction with Marshall Roundabout westwards to its junction with Ludgate Roundabout, a distance of 180 metres or thereby. (Local Diversion: Auld Brig Road, Greenside Street, Broad Street, Castle Street, Glasshouse Loan or B9096, Kellie Place, Ludgate). (Through traffic: via B9096). The order runs from 2100 hours until 2400 hours on Thursday 18th September 2014, and is required for the Scottish Independence Referendum, to allow staff to off-load ballot boxes at the main door. Access for Earl of Mar Court residents and staff dropping off ballot boxes is via Marshall only. 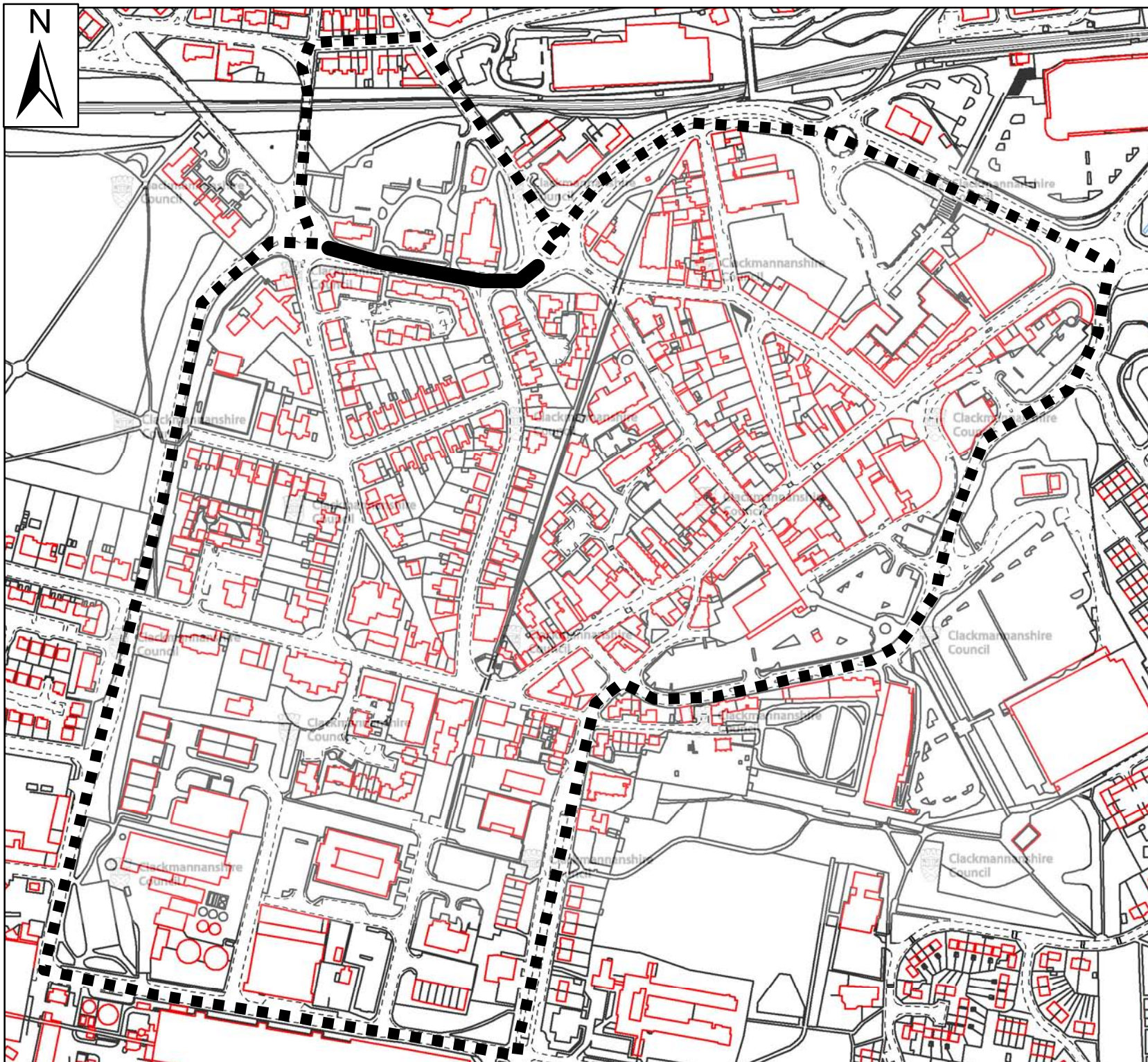
