



**(HILTON ROAD, ALLOA - SOUTH SECTION)
(TEMPORARY WAITING RESTRICTIONS) ORDER 2014**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Hilton Road, Alloa - South Section) (Temporary Waiting Restrictions) Order 2014" and notwithstanding the date hereof shall come into operation on the 11th October 2014.

2. The effect of this Order shall be that there will be no waiting at any time during:-

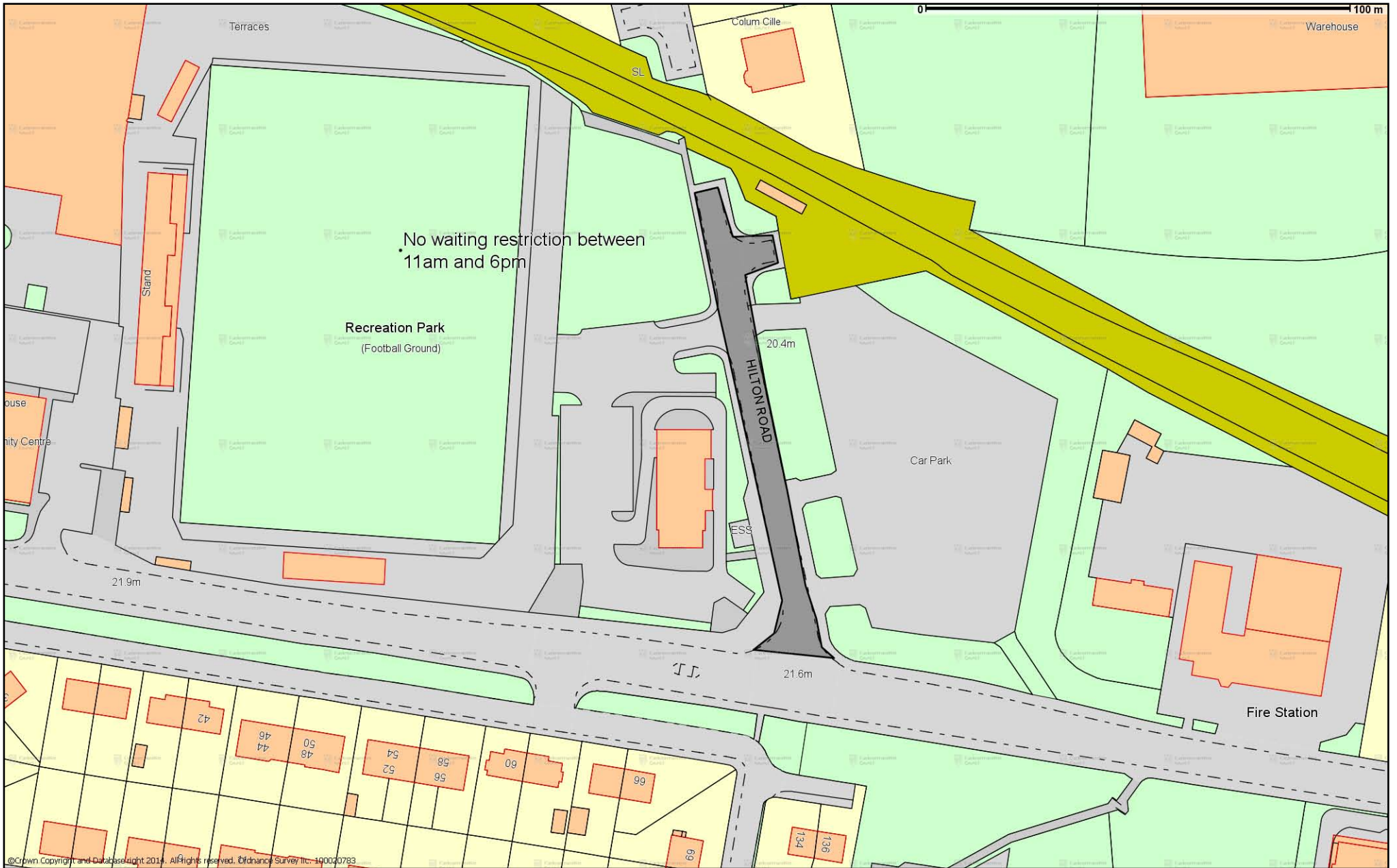
