



**(C112 WOODSIDE ROAD, BY FORESTMILL)

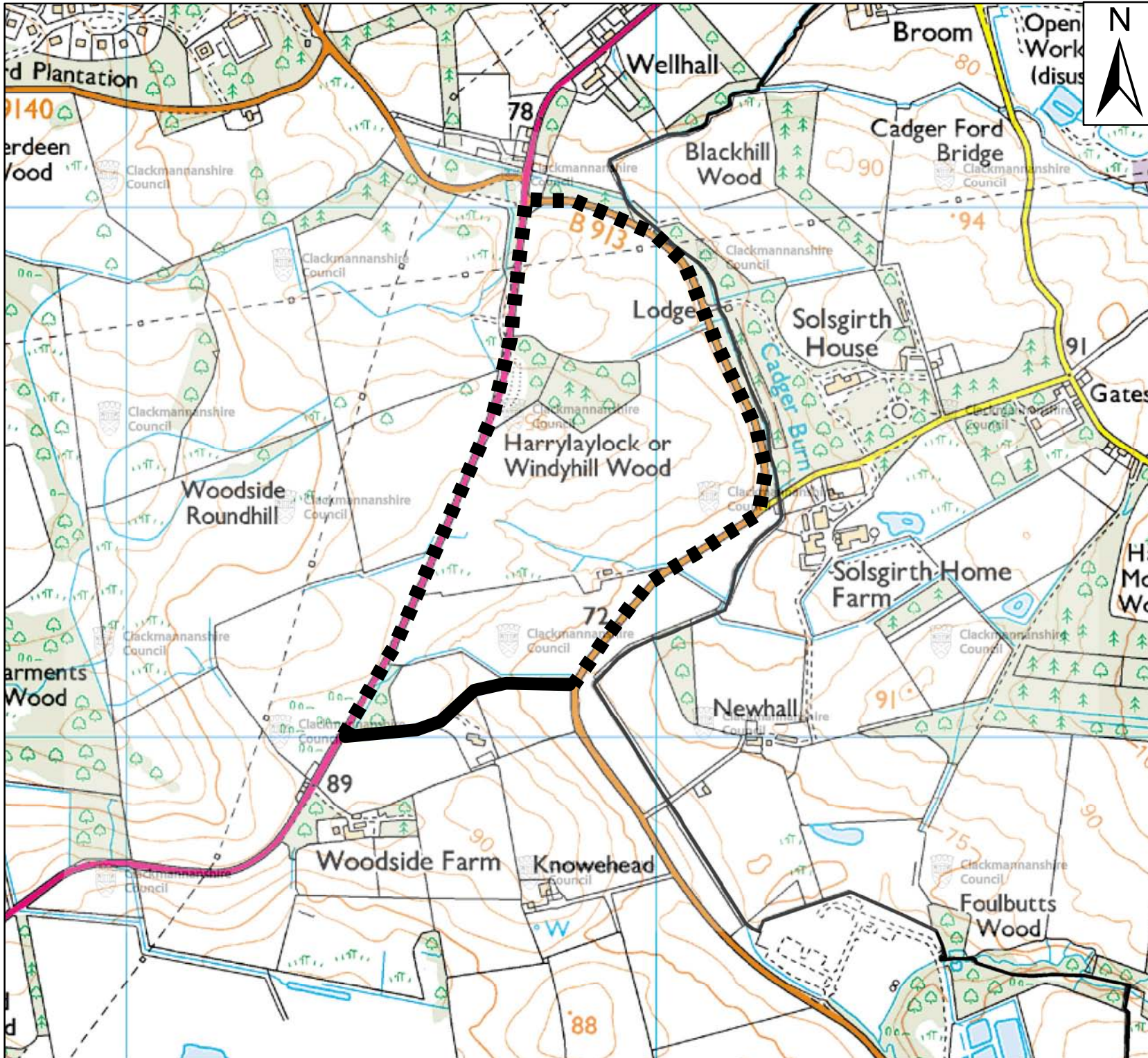
