



**(MAR PLACE AND PARKHEAD ROAD, SAUCHIE)
(TEMPORARY CLOSURE) ORDER 2014**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Mar Place and Parkhead Road, Sauchie) (Temporary Closure) Order 2014" and notwithstanding the date hereof shall come into operation on the 9th November 2014.
2. The effect of this Order shall be to close to vehicles:-
The period from 1215 hours until 1315 hours on Sunday 9th November 2014 on the section described in the Schedule attached. The temporary closure is required to facilitate the Armistice Ceremony.

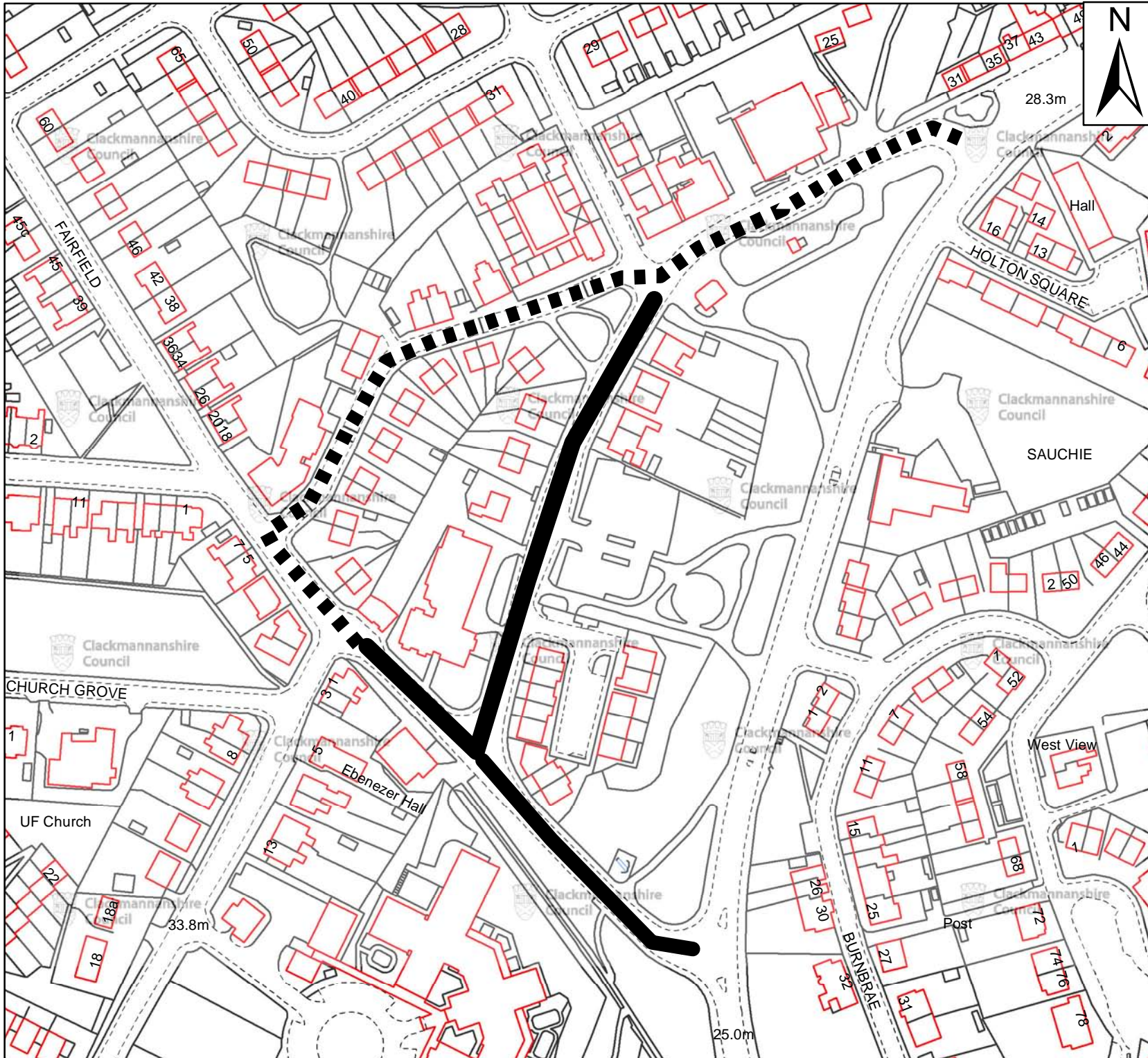
