



**(B9096 TULLIBODY ROAD, ALLOA)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B9096 Tullibody Road, Alloa) (Temporary Waiting Restrictions) Order 2014" and notwithstanding the date hereof shall come into operation on the 3rd November 2014.
2. The effect of this Order shall be that there will be no waiting at any time during:-
The period from 1100 hours until 1630 hours on Saturday 22nd November 2014 on the section described in the Schedule attached. The temporary "no waiting restrictions" are necessary to allow free flow of traffic during a cross country event at Lornshill Academy.

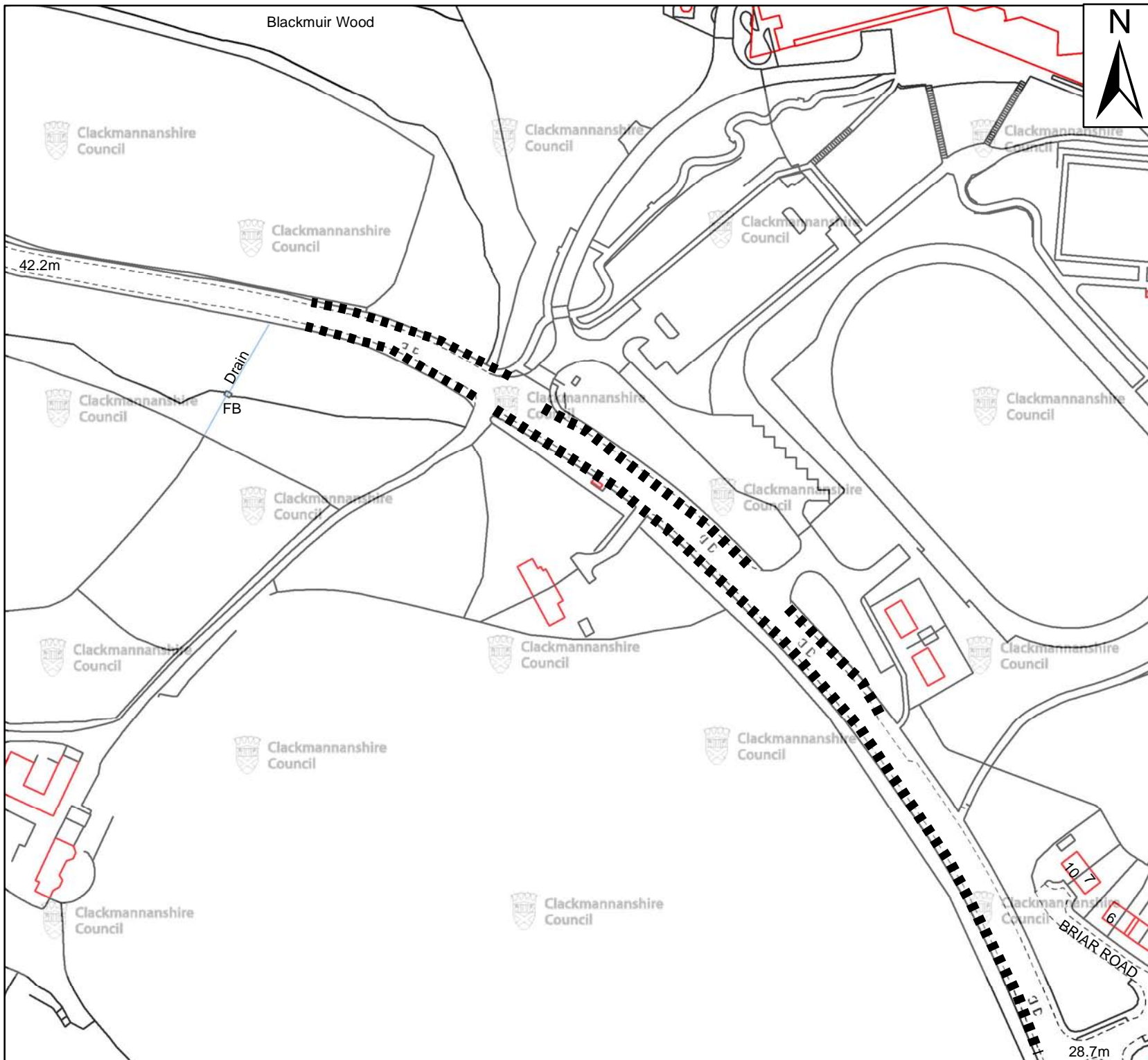
