

# (VARIOUS STREETS, MENSTRIE) (ONE-WAY TRAFFIC) EXPERIMENTAL ORDER 2015

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Section 1(1) and (2), 2(1) to (3), 4(1), 9 and 10(2) of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Parts III and IV of Schedule 9 of the said Act of 1984, hereby make the following Experimental Order:-

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Menstrie) (One-Way Traffic) Experimental Order 2015" and shall come into operation on the 1 May 2015.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. No person shall drive or cause or permit to be driven any vehicle on the length of road specified in the Schedule to this Order other than in the direction specified in the said Schedule and shown on the plan annexed and signed as relative hereto.
- 4. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

Castle Road, Menstrie	From its junction with Brook Street eastwards until its junction with Menstrie Place, a distance of 40 metres or thereby.
Menstrie Place, Menstrie	From its junction with Castle Road southwards then eastwards until its junction with Elmbank, a distance of 135 metres or thereby.
Elmbank, Menstrie	From its junction with Menstrie Place eastwards until its junction with Menstrie Primary School Access, a distance of 70 metres or thereby.

The order is intended as an experiment to determine the effect a one-way restriction on the Castle Road, Menstrie Place and Elmbank Menstrie will have in reducing traffic congestion within the area.

The Council proposes to make the above Experimental Order under Sections 1(1) and (2), 2(1) to (3), 4(1), 9 and 10(2) and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate Castle Road, Menstrie (From its junction with Brook Street eastwards until its junction with Menstrie Place, a distance of 40 metres or thereby); Menstrie Place, Menstrie (From its junction with Castle Road southwards then eastwards until its junction with Elmbank, a distance of 135 metres or thereby); Elmbank, Menstrie (From its junction with Menstrie Place eastwards until its junction with Menstrie Place eastwards until its junction with Menstrie (From its junction with Menstrie Place eastwards until its junction with Menstrie Place eastwards until its junction with Menstrie Primary Access, a distance of 70 metres or thereby) as a One Way Traffic System (West to East) which is being introduced for period of twelve months as an experiment to determine its effect in reducing traffic congestion within the area. Its maximum duration in terms of the act is eighteen months. The Council has made the above Order under Sections 1(1) and (2), 2(1) to (3), 4(1), 9 and 10(2) and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate Castle Road, Menstrie (From its junction with Brook Street eastwards until its junction with Menstrie Place, a distance of 40 metres or thereby); Menstrie Place, Menstrie (From its junction with Castle Road southwards then eastwards until its junction with Elmbank, a distance of 135 metres or thereby); Elmbank, Menstrie (From its junction with Menstrie Place eastwards until its junction with Menstrie Place eastwards until its junction with Menstrie Primary Access, a distance of 70 metres or thereby) as a One Way Traffic System (West to East) which is being introduced for period of twelve months as an experiment to determine its effect in reducing traffic congestion within the area. Its maximum duration in terms of the act is eighteen months. Anyone wishing to question the validity of any of the provisions within this order should write to the Court of session within six weeks of 01/05/15. The Clackmannanshire Council has made the above named Order under Sections 1(1) and (2), 2(1) to (3), 4(1), 9, 10(2) and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 on 20 April 2015.

FULL DETAILS of this Order is as published in the Alloa Advertiser on the 4 March 2015, and will designate the sections of roads described in the Schedule as a One Way Traffic System which is being introduced for period of twelve months as an experiment to determine its effect in reducing traffic congestion within the area. Its maximum duration in terms of the act is eighteen months.

Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that if any requirement therein has not been complied with, may, within six weeks from 1 May 2015 apply to the Court of Session for this purpose.
