

(CLACKMANNAN) (PARKING SPACES FOR DISABLED PERSONS) ORDER 2015

Clackmannanshire Council in exercise of their powers under Section 32(1) and 35(1) of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:

- This Order may be cited as "The Clackmannanshire Council (Clackmannan) (Parking Spaces for Disabled Persons) Order 2015" and shall come into operation on the 1 May 2015.
- The effect of this Order will be to designate the sections of road described in the Schedule hereto and shown on the plans annexed and signed as relative hereto as parking spaces for disabled persons' vehicles.
- 3. The Central Region (On-Street Parking Spaces for Disabled Persons (No. 49) Order 1994 in so far as it relates to No. 49 Port Street Clackmannan, is hereby revoked.

The Central Region (On-Street Parking Spaces for Disabled Persons (No. 48) Order 1994 in so far as it relates to No. 48 - Kersegreen Road, Clackmannan, is hereby revoked.

The Clackmannanshire Council (On-Street Parking Places for Disabled Persons (No. 7) Order 1997 in so far as it relates to No. 7 - 13 Castle Terrace, Clackmannan, is hereby revoked.

The Clackmannanshire Council (On-Street Parking for Disabled Persons) (No. 36) Order 1999 in so far as it relates to No. 36 - Main Street, Clackmannan, is hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Nos. 72, 73, 74, 75, 76, 77, 78, 79 and 80) Order 2009 in so far as it relates to No. 72 - Mayfield Crescent, Clackmannan, is hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons) Nos. 81 to 90) Order 2010 in so far at it relates to No. 84 - Lochies Road, Clackmannan; No. 85 - Lochies Road, Clackmannan; and No. 87 Woodside Terrace, Clackmannan, is hereby revoked.

The Clackmannanshire Council (Parking Space for Disabled Person) (Nos. 121 - 120) Order 2011 in so far as it relates to Nos. 114, 115, 116 and 117 all of Devonway, Clackmannan are hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Nos. 121 - 134) in so far as it relates to Nos. 123 and 124 - both of Garden Terrace, Clackmannan are hereby revoked.

- 4. In this Order except where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them:
 - (a) "disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge issued, or having effect as if issued under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970;
 - (b) "disabled person" means the disabled driver of or a disabled passenger in a motor vehicle, being such a disabled person as is described in regulation 4 of the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 in respect of whom any Council has issued a disabled person's badge and a valid badge is conspicuously displayed in the relevant position on the vehicle;
 - (c) "disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000;
 - (d) "relevant position" means:
 - in the case of a vehicle fitted with a front windscreen the disabled person's badge is exhibited thereon with the obverse site facing forwards on the near side of and immediately behind the windscreen; and
 - (ii) in the case of a vehicle not fitted with a front windscreen the disabled person's badge is exhibited in a conspicuous position on the front or nearside of the vehicle.
