



**(CHURCH STREET, ALLOA)
(TEMPORARY CLOSURE) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Church Street, Alloa) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 27th April 2015.
2. The effect of this Order shall be to close to vehicles:-
The period from 0930 hours on Monday 27th April 2015 until 1530 hours on Wednesday 29th April 2015 on the section described in the Schedule attached. The temporary closure is required for Openreach to repair cables.

The Council has made "The Clackmannanshire Council (Church Street, Alloa) (Temporary Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 8th April 2015: to close to vehicles at Church Street, Alloa - North Bound: from its junction with Glebe Terrace northwards until its junction with Marshill, a distance of 91 metres or thereby. (Diversion Route: Via Glebe Terrace, Ludgate, Marshill and vice versa). 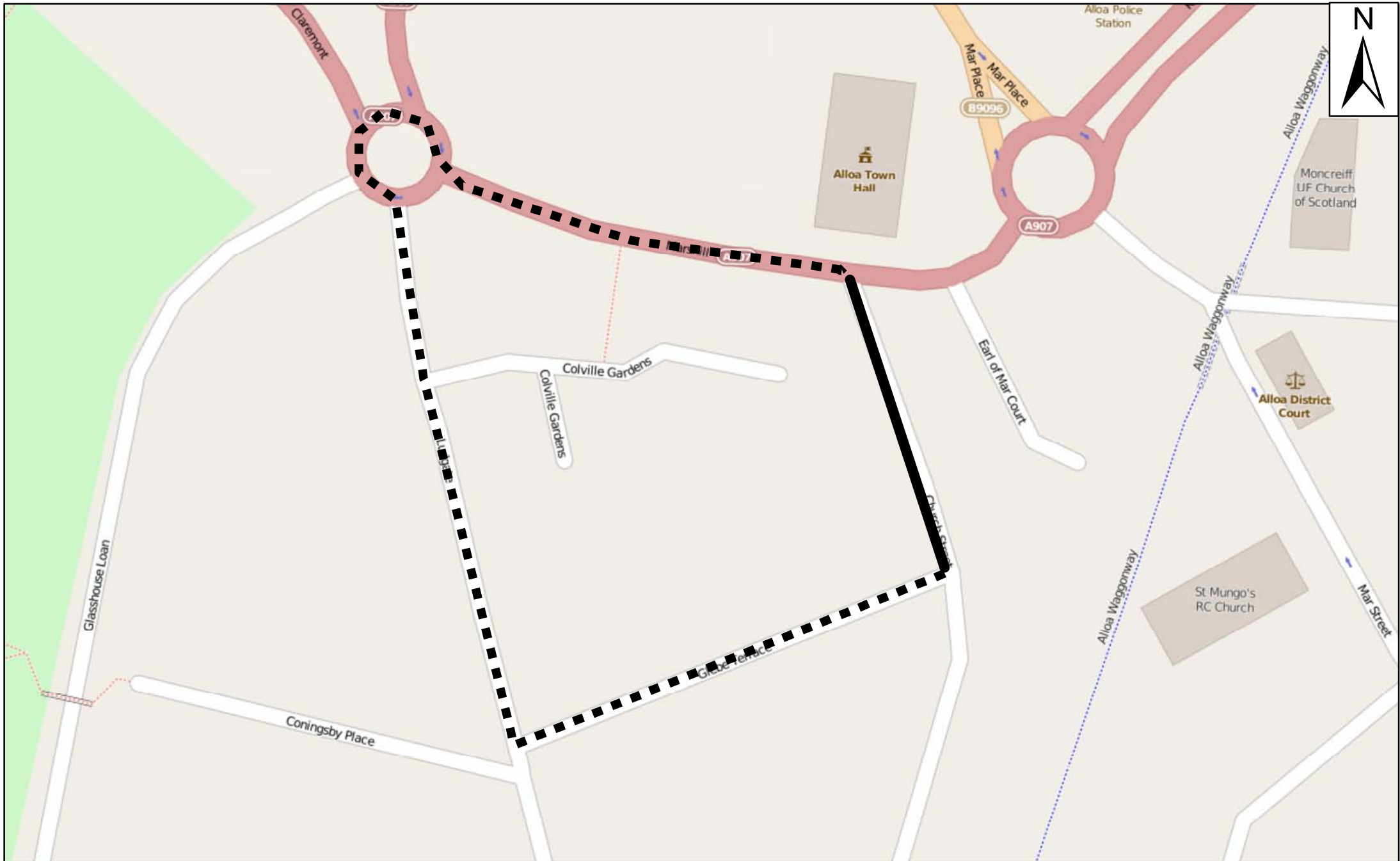
