



**(C59 GARTARRY TO KENNET)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C59 Gartarry to Kennet) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 8th June 2015.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 8th June 2015 for a period of 12 days or until completion the section described in the Schedule attached. The temporary closure is required for resurfacing works.

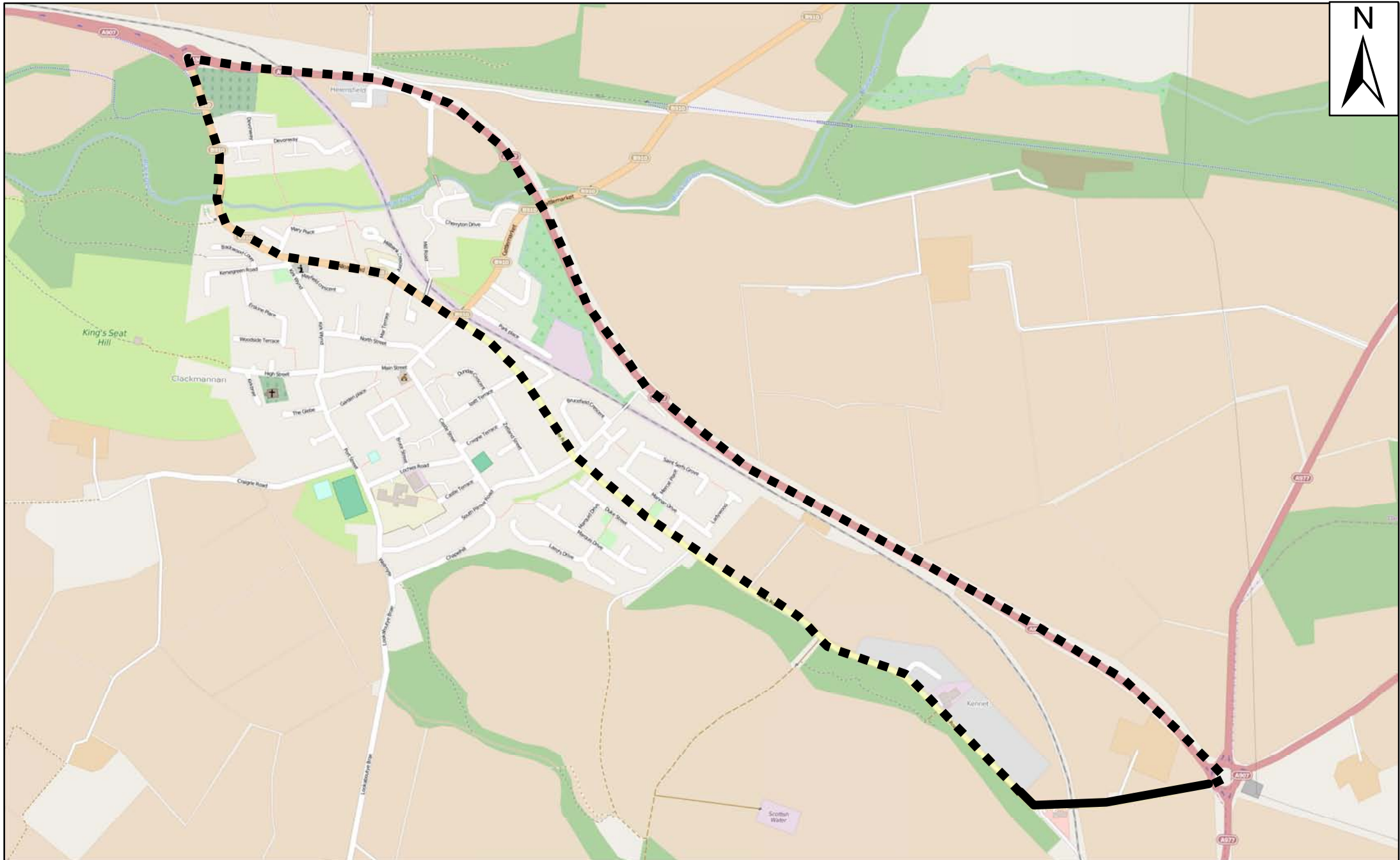
