

(BLACKGRANGE, CAMBUS) (TEMPORARY CLOSURE) ORDER 2015

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Blackgrange, Cambus) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 28th June 2015.
- The effect of this Order shall be to close to vehicles: The period from 2300 hours on Sunday 28th June 2015 until 0700 hours on Monday 29th June 2015 on the section described in the Schedule attached. The temporary closure is required for maintenance to level crossing.
