The Council has made "The Clackmannanshire Council (9140 Collylands to Fishcross) (Temporary Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 24th June 2015: to close to vehicles at B9140 Collylands to Fishcross from its junction with Collylands Roundabout eastwards to its junction with mini roundabout at A908 Fishcross, a distance of 1550 metres or thereby. (Diversion Route: Via B9140, C101, A91, A908 and vice versa). (Diversion Route HGVs: Via B9140, C110, A91, A908 and vice versa). The order runs from 0800 hours on Monday 3rd August 2015 for a period of 12 weeks or until completion and is required for road improvements.
