



**(VARIOUS STREETS, COALSNAUGHTON)
(20 MPH LIMIT) ORDER 2015**

Clackmannanshire Council, in exercise of the powers conferred upon it by Section 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Order may be cited as "The Clackmannanshire Council (Various Streets, Coalsnaughton) (20 mph Limit) Order 2015" and shall come into operation on 16 October 2015.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (3) A speed limit of 20 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the said lengths of roads.
- (4) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

Clackmannanshire Council has made the above named Order under Section 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) on 6 October 2015.

FULL DETAILS of this Order is as published in the Alloa Advertiser on the 29 July 2015 and will designate the sections of roads described in the Schedule as a 20 miles per hour speed limit to ensure that traffic speeds are limited to a speed compatible with the local environment. This will designate the sections of roads in COALSNAUGHTON: Benbuck View, Blackfaulds Street (from its junction with Main Street westwards), Carmichael Place, Gartinny, Glenhead Avenue, Hawthorn Avenue, Mount Pleasant, Muircot Place, Nechtan Drive, Park Street, School Terrace, Sheardale Drive, Simpson Drive, The Meadows, Thompson Place, and Woodhead Place for their entirety and Main Street (from its junction with B9140 northwards until the north boundary of number 36 Main Street, a distance of 305 metres or thereby, as a 20 miles per hour speed limit to ensure that traffic speeds are limited to a speed compatible with the local environment.
