



**(BRIDGE STREET, DOLLAR)
(TEMPORARY SUSPENSION OF WAITING, LOADING AND UNLOADING) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Bridge Street, Dollar) (Temporary Suspension of Waiting, Loading and Unloading) Order 2015" and notwithstanding the date hereof shall come into operation on the 1st September 2015.
2. The effect of this Order shall be to suspend waiting, loading and unloading of vehicles:-
The period from 0800 hours on Monday 14th September 2015 for a period of 2 days or until completion on the section described in the Schedule attached. The temporary suspension of waiting, loading and unloading is required to allow the layby to be resurfaced.

The order runs from 0800 hours on Monday 14th September 2015 for a period of 2 days or until completion and is required to allow the layby to be resurfaced. 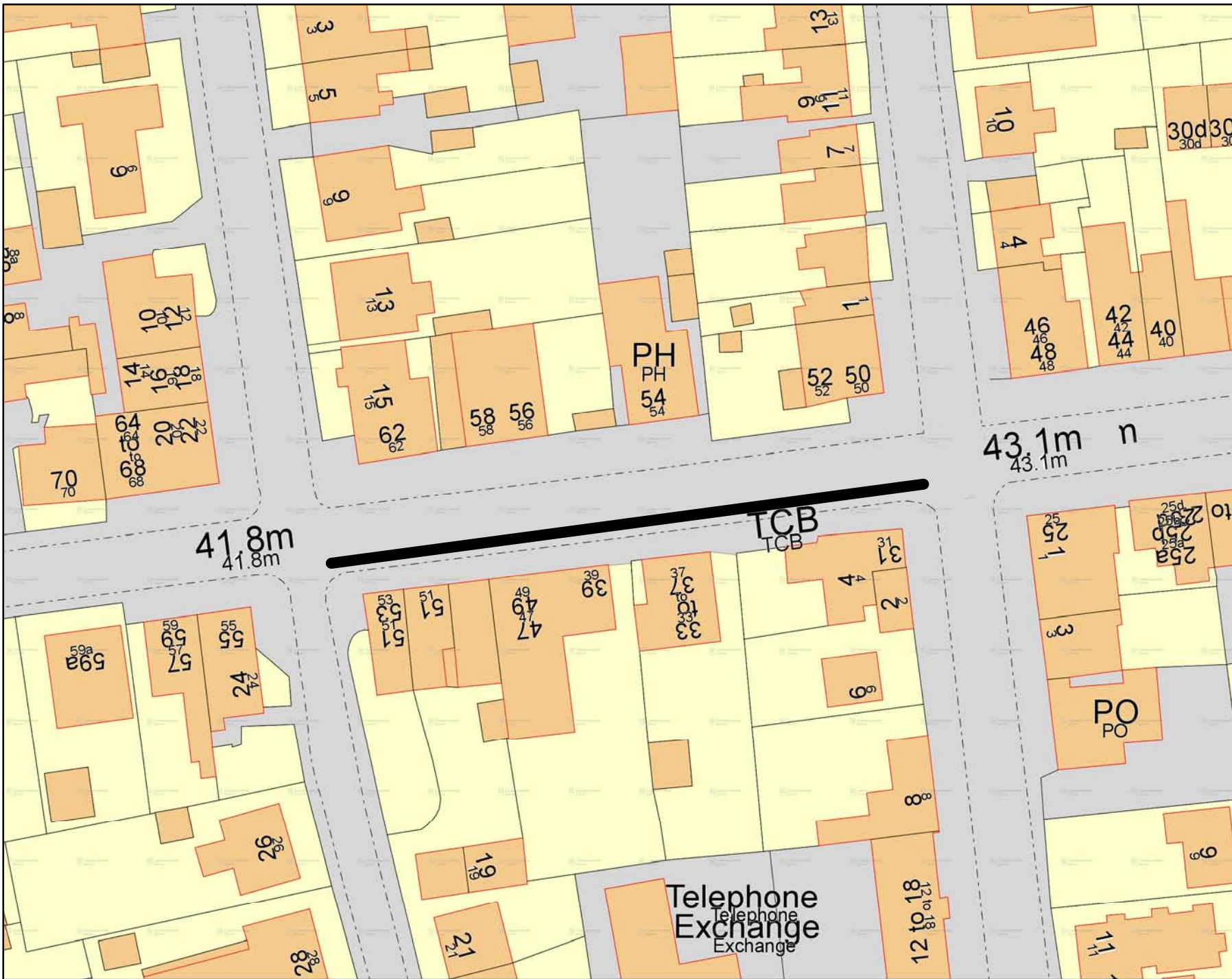
