

(VARIOUS STREETS, ALLOA) (TEMPORARY CLOSURE) ORDER 2015

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 2nd September 2015.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 28th September 2015 for a period of 5 days or until completion on the section described in the Schedule attached. The temporary closure is required for resurfacing and to limit the length of inconvenience to residents and businesses.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 2nd September 2015: to close to vehicles at Mar Street, Alloa from its junction with Mill Street north westwards until its junction with Marshill Roundabout, for a distance of 237 metres or thereby, and Burgh Mews, Alloa from its junction with Mar Street south westwards for a distance of 41 metres or thereby. (Alternative Route: Via Mill Street, Shillinghill). The order runs from 0800 hours on Monday 28th September 2015 for a period of 5 days or until completion and is required for resurfacing and to limit the length of inconvenience to residents and businesses.
