



**(BURGH MEWS, ALLOA)
(TEMPORARY SUSPENSION OF ONE WAY) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Burgh Mews, Alloa) (Temporary Suspension of One Way) Order 2015" and notwithstanding the date hereof shall come into operation on the 2nd September 2015.
2. The effect of this Order shall be to temporarily suspend the one way traffic system:-
The period from 0800 hours on Monday 28th September 2015 for a period of 5 days or until completion on the section described in the Schedule attached. The temporary suspension of one way is required to allow access and egress from Burgh Mews for residents. Access will be controlled by STOP and GO boards between 8 a.m. and 5 p.m., thereafter residents will have to enter and exit with caution.

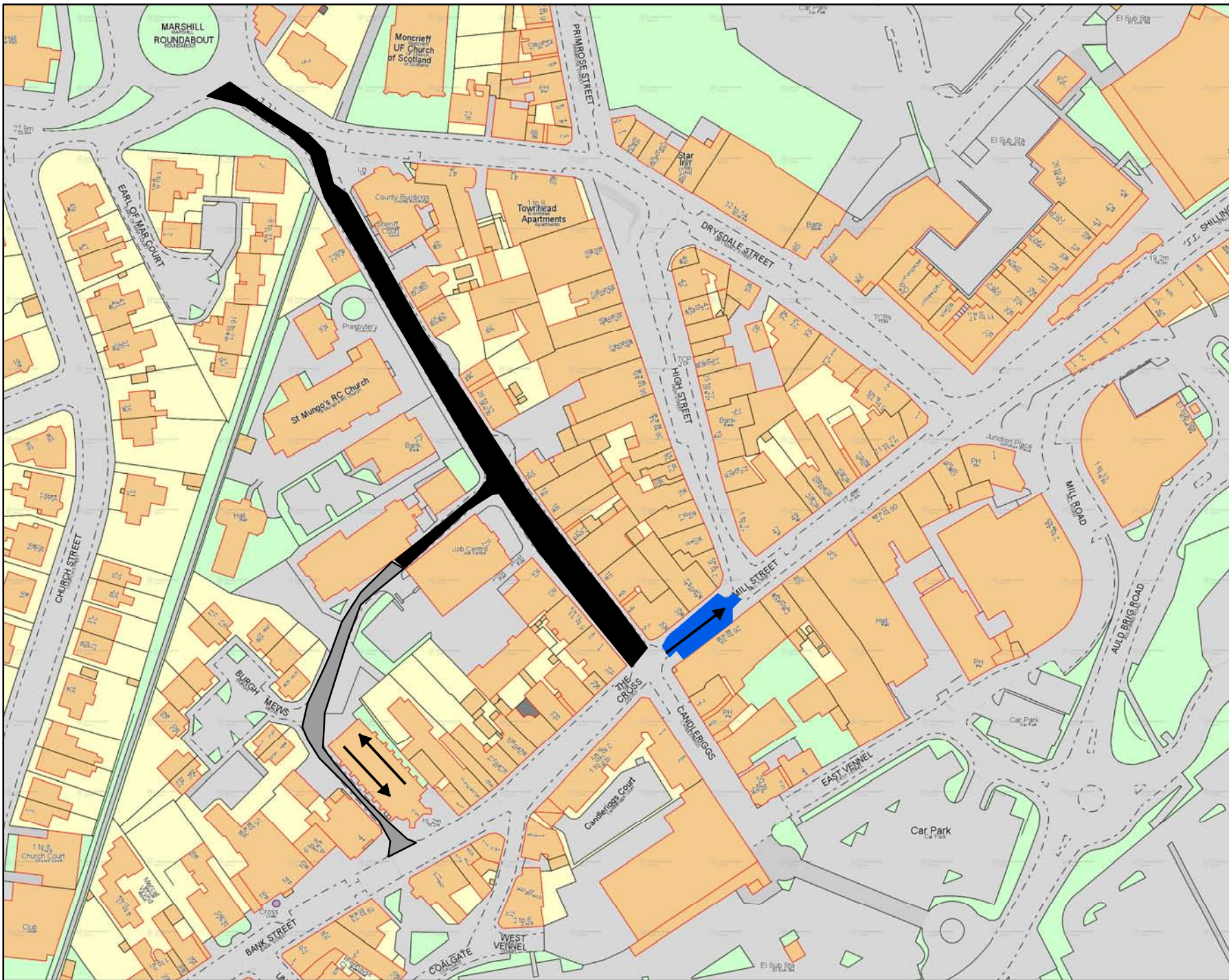
