



**(DELPH ROAD, TULLIBODY)
(TEMPORARY FOOTPATH CLOSURE) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Delph Road, Tullibody) (Temporary Footpath Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 10th September 2015.

2. The effect of this Order shall be to close the footpath:-
The period from 0800 hours on Monday 21st September 2015 for a period of 4 weeks or until completion on the section described in the Schedule attached. The temporary footpath closure is required for service installation.

The Council has made "The Clackmannanshire Council (Delph Road, Tullibody) (Temporary Footpath Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 10th September 2015: to close to pedestrians at Delph Road, Tullibody: North Side - From the east gable end of number 19, eastwards for a distance of 75 metres or thereby; and at South Side - From outside number 10 to number 16, a distance of 34 metres or thereby. Access for residents affected where possible. The order runs from 0800 hours on Monday 21st September 2015 for a period of 4 weeks or until completion and is required for service installation. 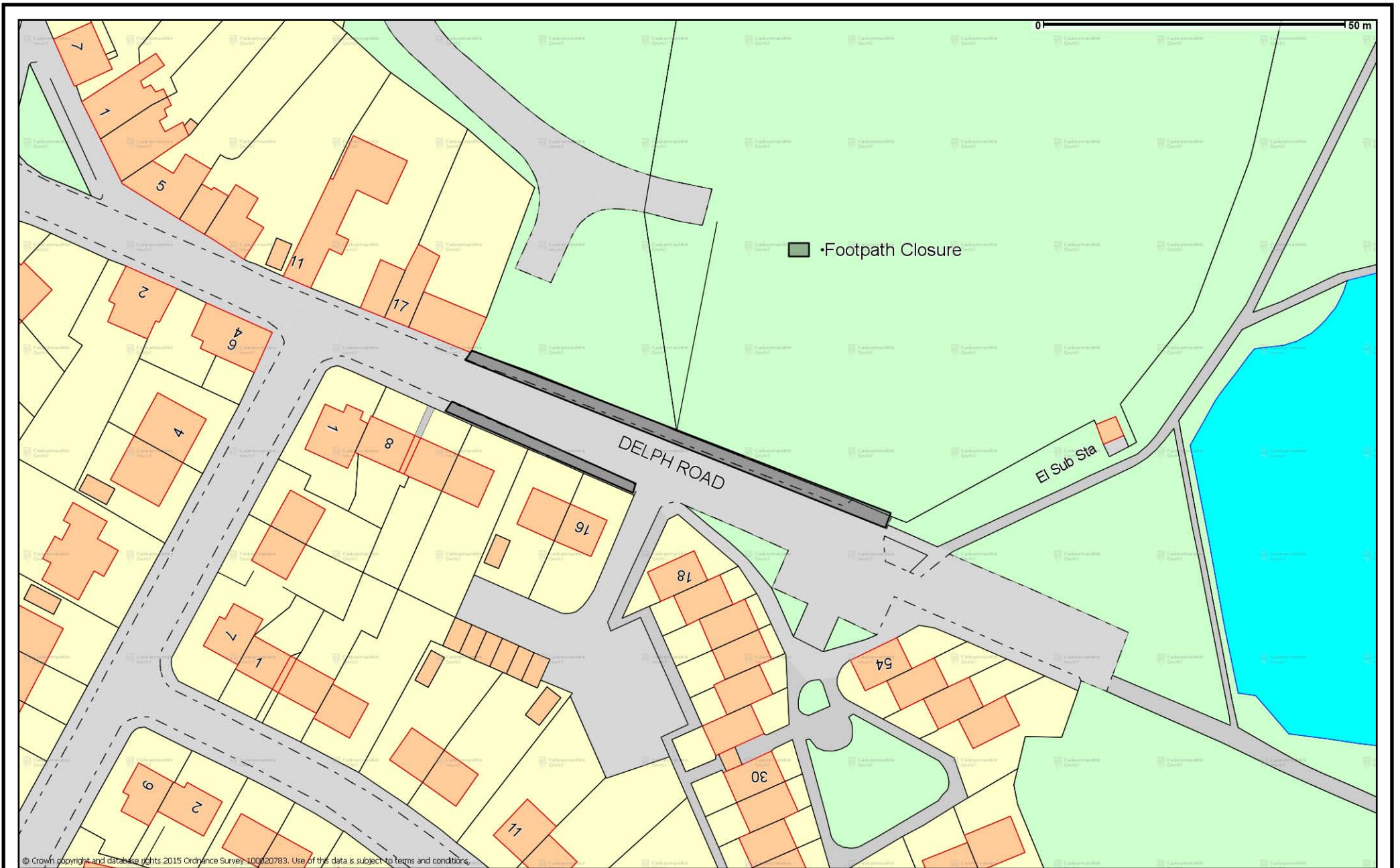
