



**(B908 ALVA TO COLLYLANDS)
(TEMPORARY CLOSURE) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B908 Alva to Collylands) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 15th October 2015.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 16th November 2015 until 1700 hours on Tuesday 17th November 2015 or until completion on the section described in the Schedule attached. The temporary closure is required for carriageway repairs.



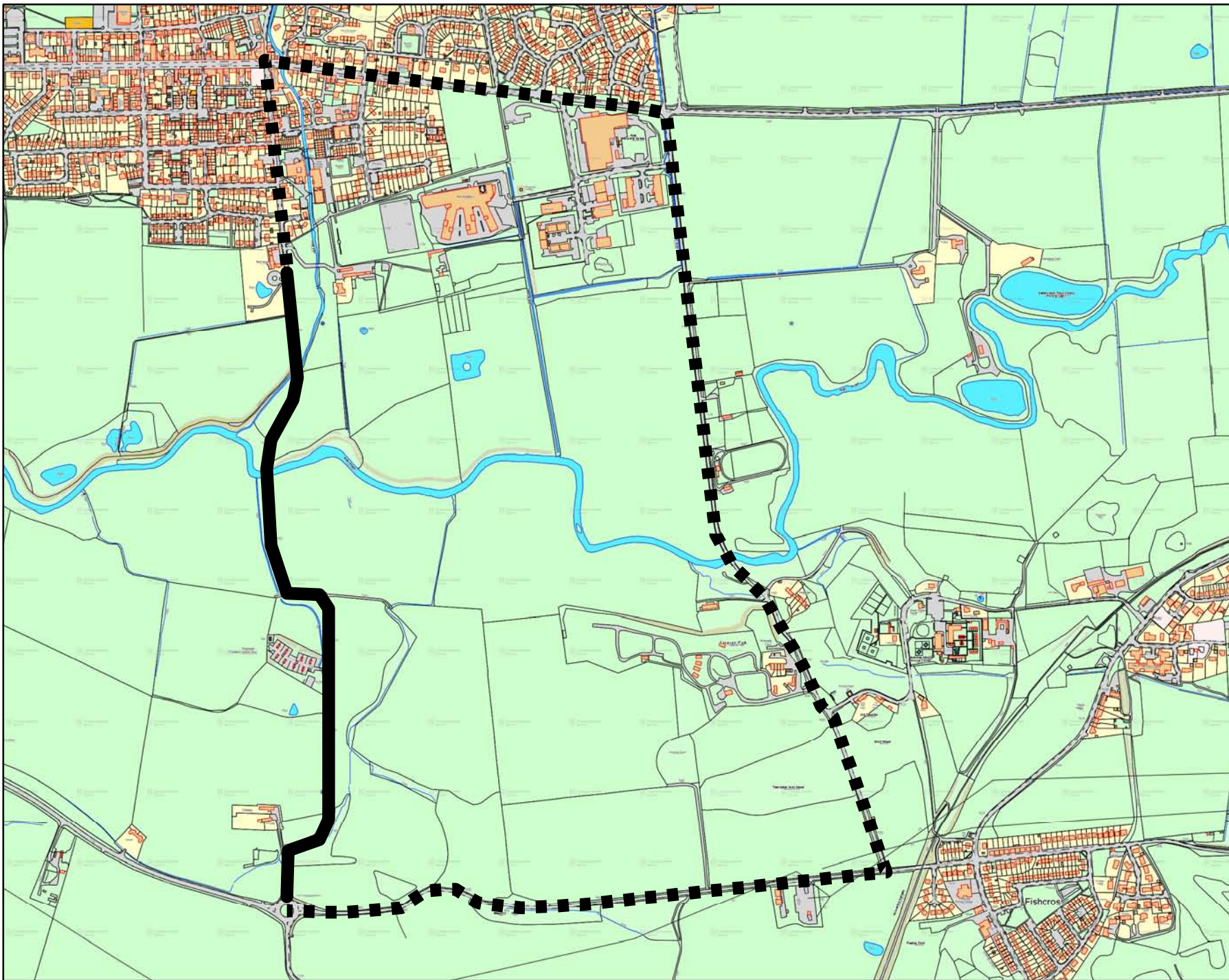
