1. This Order may be cited as "The Clackmannanshire Council (High Street/Mill Street, Alloa) (Temporary Closure) Order 2015 and notwithstanding the date hereof shall come into operation on the 23rd November 2015.
2. The effect of this Order shall be to close to vehicles:-
The period from 1330 hours until 1500 hours on Saturday 12th December 2015 on the section described in the Schedule attached. The temporary closure is necessary for the Reindeer Parade.

The Council has made "The Clackmannanshire Council (High Street/Mill Street, Alloa) (Temporary Closure) Order 2015, under the Road Traffic Regulation Act 1984 (as amended) on 23rd November 2015: to close to vehicles at **High Street, Alloa** from its junction with Drysdale Street to its junction with Mill Street, a distance of 130 metres or thereby, and **Mill Street, Alloa** from its junction with Mar Street to its junction with Drysdale Street, a distance of 90 metres or thereby. (Alternative Route: There is no alternative route available). The order runs from 1330 hours until 1500 hours on Saturday 12th December 2015 and is necessary for the Reindeer Parade. 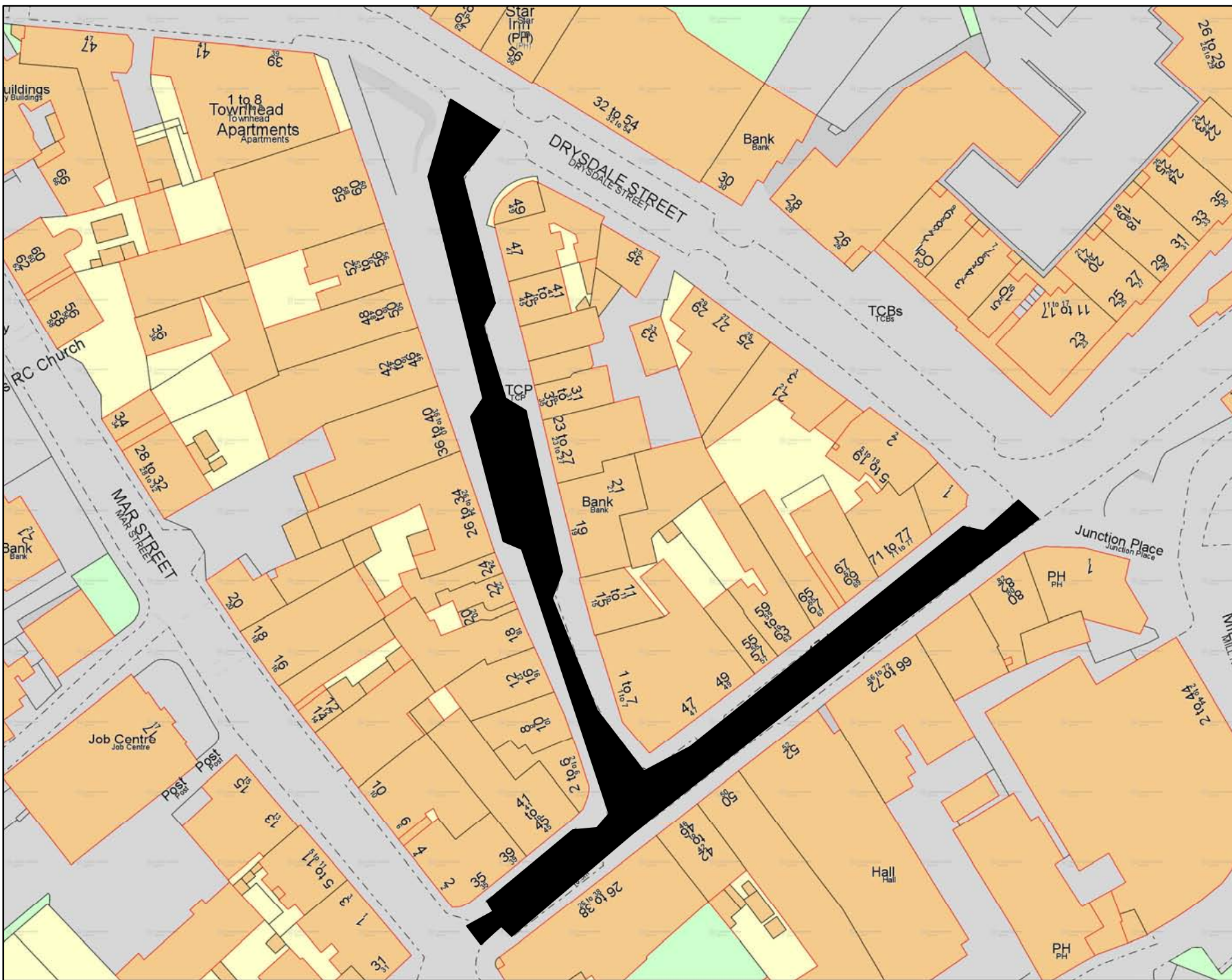
