The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Park Street, Tillicoultry) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 24th November 2015.
- The effect of this Order shall be to close to vehicles:-The period from 2100 hours on Monday 4th January 2016 until 0600 hours on Tuesday 5th January 2016 on the section described in the Schedule attached. The temporary closure is required for BT works to access carriagebox.

The Council has made "The Clackmannanshire Council (Park Street, Tillicoultry) (Temporary Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 24th November 2015: to close to vehicles at Park Street, Tillicoultry from its junction with A91 southwards for a distance of 50 metres or thereby. (Alternative Route: Via Park Street, Hareburn Road, Lower Mill Street, A91 and vice versa OR Park Street, Stoneyacre, Ann Street, Bank Street, A91 and vice versa). The order runs from 2100 hours on Monday 4th January 2016 until 0600 hours on Tuesday 5th January 2016 and is necessary for BT works to access carriagebox.
