



**(CLAREMONT AND KELLIE PLACE, ALLOA)  
(TEMPORARY CLOSURE) ORDER 2015**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Claremont and Kellie Place, Alloa) (Temporary Closure) Order 2015" and notwithstanding the date hereof shall come into operation on the 2nd December 2015.
  
2. The effect of this Order shall be to close to vehicles:-  
The period from 0800 hours on Monday 14th December 2015 for a period of 1 week or until completion on the section described in the Schedule attached. The temporary closure is required to install speed tables and reshape a junction.

### **The Clackmannanshire Council (Claremont and Kellie Place, Alloa) (Temporary Closure) Order 2015**

The Council has made "The Clackmannanshire Council (Claremont and Kellie Place, Alloa) (Temporary Closure) Order 2015", under the Road Traffic Regulation Act 1984 (as amended) on 2nd December 2015: to close to vehicles at **Claremont, Alloa** from its junction with A907 Ludgate westwards to its junction with Alexandra Drive, a distance of 260 metres or thereby; **Claremont, Alloa** from its junction with Alexandra Drive westwards to its junction with Churchill Street, a distance of 100 metres or thereby. (Diversion Route: Via Alexandra Drive, A907 Stirling Road and vice versa), and also at **Kellie Place, Alloa** from its junction with B9096 westwards to its junction with Ludgate, a distance of 92 metres or thereby. (Diversion Route: Via Mar Place, Marshill, Stirling Road, Kellie Place and Ludgate). Access to be maintained for residents of Kellie Place and Ludgate. The order runs from 0800 hours on Monday 14th December 2015 for a period of 1 week or until completion and is necessary for works to install speed tables and reshape a junction. 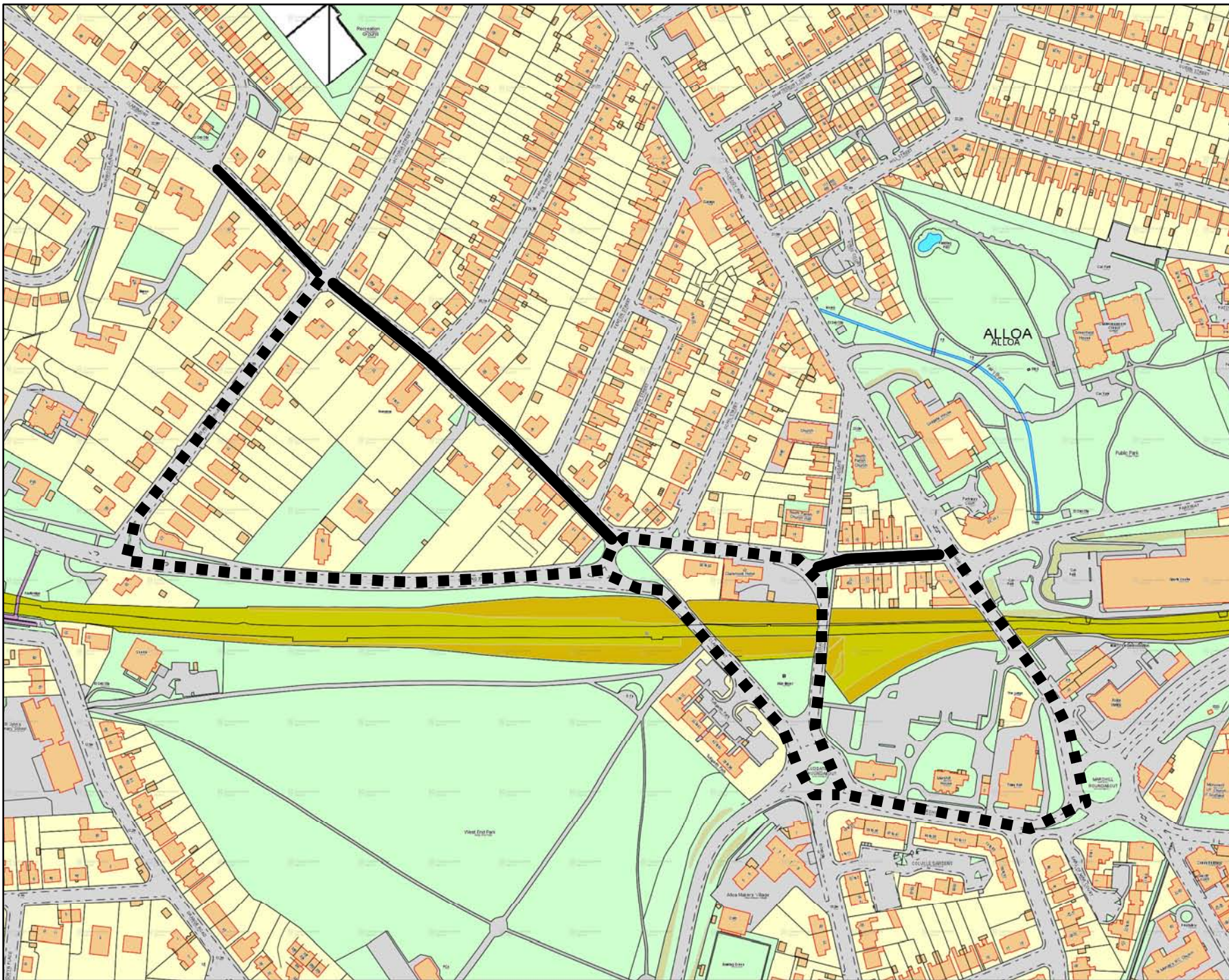
