

(MENSTRIE) (PARKING SPACES FOR DISABLED PERSONS) ORDER 2016

Clackmannanshire Council in exercise of their powers under Section 32(1) and 35(1) of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:

- This Order may be cited as "The Clackmannanshire Council (Menstrie) (Parking Spaces for Disabled Persons) Order 2016" and shall come into operation on the 25 March 2016.
- The effect of this Order will be to designate the sections of road described in the Schedule hereto and shown on the plans annexed and signed as relative hereto as parking spaces for disabled persons' vehicles.
- 3. The Central Region (On-Street Parking Spaces for Disabled Persons (No. 28) Order 1993 in so far as it relates to No. 14 Elmbank, Menstrie, is hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons (Nos. 62, 63, 64, 65 and 66) Order 2009 in so far as it relates to No. 62 - A91 Main Street, Menstrie and No. 63 - Dumyat Leisure Centre Car Park, Menstrie are hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Nos. 72, 73, 74, 75, 76, 77, 78, 79 and 80) Order 2009 in so far as it relates to No. 73 - Midtown, Menstrie, is hereby revoked.

The Clackmannanshire Council (Parking Spaces for Disabled Persons) (Nos. 91, 92, 93, 94, 95 96 and 97) Order 2010 in so far at it relates to No. 92 - Abercrombie Place, Menstrie, is hereby revoked.

The Clackmannanshire Council (Parking Space for Disabled Person) (Nos. 112, 113, 114, 115, 116, 117, 118, 119 and 120) Order 2011 in so far as it relates to No. 118 - Dumyat Road, Menstrie, is hereby revoked.

4. In this Order except where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them:

- (a) "disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge issued, or having effect as if issued under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970;
- (b) "disabled person" means the disabled driver of or a disabled passenger in a motor vehicle, being such a disabled person as is described in regulation 4 of the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 in respect of whom any Council has issued a disabled person's badge and a valid badge is conspicuously displayed in the relevant position on the vehicle;
- (c) "disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000;
- (d) "relevant position" means:
 - in the case of a vehicle fitted with a front windscreen the disabled person's badge is exhibited thereon with the obverse site facing forwards on the near side of and immediately behind the windscreen; and
 - (ii) in the case of a vehicle not fitted with a front windscreen the disabled person's badge is exhibited in a conspicuous position on the front or nearside of the vehicle.

The Council has made the above Order under Section 32(1) and 35(1) of the Road Traffic Regulation Act 1984 (as amended) which will designate the sections of road listed as parking spaces for disabled persons' vehicles within Menstrie: M1 Midtown - North Side from the west boundary of No. 13 eastwards for a distance of 6.6 metres or thereby; M2 Midtown - West Side from a point 21 metres or thereby northwards of its junction with Main Street West, northwards for a distance of 6.6 metres or thereby; M3 Midtown - West Side from a point 28 metres or thereby northwards of its junction with Main Street West, northwards for a distance of 6.6 metres or thereby; M4 Elmbank - South Side from a point 45 metres or thereby west of its junction with Forthvale, westwards for a distance of 6.6 metres or thereby; M5 Abercrombie Place - West Side from a point 10 metres or thereby south of its junction with Main Street West, southwards for a distance of 6.6 metres or thereby; M6 Main Street West Outside Church - South Side from a point 33 metres or thereby west of its junction with Park Road, westwards for a distance of 6.6 metres or thereby; M7 The Charrier - West Side from the gable end of block 39 - 49, southwards for a distance of 3 metres or thereby; M8 Main Street West - North Side from a point 36 metres or thereby west of Park Road, westwards for a distance of 6.6 metres or thereby; M9 Dumyat Road - East Side from a point 10 metres or thereby south of its junction with Abercrombie Place, southwards for a distance of 6.6 metres or thereby; M10 Dumyat Leisure Centre - East Side of the car park - on the north side of the access ramp, a distance of 3 metres or thereby; M11 Windsor Street - West Side from a point 132 metres or thereby south of its junction with A91, southwards for a distance of 3.5 metres of thereby; M12 Burnside Road - South Side from a point 109 metres or thereby east of its junction with Dumyat Road, eastwards for a distance of 6.6 metres or thereby.
