**(VARIOUS STREETS, ALVA)
(TEMPORARY CLOSURES) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Closures) Order 2016" and notwithstanding the date hereof shall come into operation on the 5th February 2016.
2. The effect of this Order shall be to close to vehicles at Queen Street, Alva (Upper):-
The period from 0800 hours on Monday 15th February 2016 for a period of 5 weeks on the section described in Schedule 1 attached.
3. The effect of this Order shall be to close to pedestrians at Beauclerc Street, Alva: -
The period from 0800 hours on Monday 15th February 2016 for a period of 4 weeks on the section described in Schedule 2 attached.
4. The effect of this Order shall be to close to pedestrians at Beauclerc Street to Courthill: -
The period from 0800 hours on Monday 15th February 2016 for a period of 44 weeks on the section described in Schedule 3 attached.

The temporary closures are required for carriageway improvements and service diversions/connections.

The Clackmannanshire Council (Various Streets, Alva) (Temporary Closures) Order 2016

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Closures) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 5th February 2016 as follows:

Schedule 1: to close to vehicles at **Queen Street, Alva (Upper)** from its junction with Erskine Street northwards to its junction with Beauclerc Street, a distance of 91 metres or thereby. (Diversion Route: Via Beauclerc Street, Brook Street, The Green, The Wynd, Park Street and vice versa). The order runs from 0800 hours on Monday 15th February 2016 for a period of 5 weeks (Temporary Road Closure). **Schedule 2:** to close to pedestrians the section of footway over which a footway closure will be applicable at **Beauclerc Street, Alva** from its junction with Queen Street eastwards, for a distance of 127 metres or thereby. (Diversion Route: Via footway on northside). The order runs from 0800 hours on Monday 15th February 2016 for a period of 4 weeks (Temporary Footway Closure). **Schedule 3:** to close to pedestrians the section of footpath over which a footpath closure will be applicable at **Beauclerc Street to Courthill, Alva** from Beauclerc Street southwards to Courthill, a distance of 60 metres or thereby. (Diversion Route: Via Beauclerc Street, Henderson Place, Erskine Street and vice versa. The order runs from 0800 hours on Monday 15th February 2016 for a period of 44 weeks (Temporary Footpath Closure). The closures are necessary for carriageway improvements and service diversions/connections. 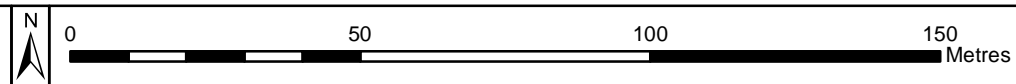
