



**(FEARNS ROAD, FORESTMILL)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Fearn's Road, Forestmill) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 3rd March 2016.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 21st March 2016 on the section described in the Schedule attached. The temporary closure is required for resurfacing of the junction.

The Council has made "The Clackmannanshire Council (Fearn's Road, Forestmill) (Temporary Closure) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 3rd March 2016: to close to vehicles at Fearn's Road, Forestmill from its junction with A977 eastwards for a distance of 25 metres or thereby. (Diversion: Via Fearn's Road, B913, Woodside Road, A977 and vice versa). The order runs from 0800 hours on Monday 21st March 2016 for a period of 2 days or until completion and is necessary for resurfacing of the junction. 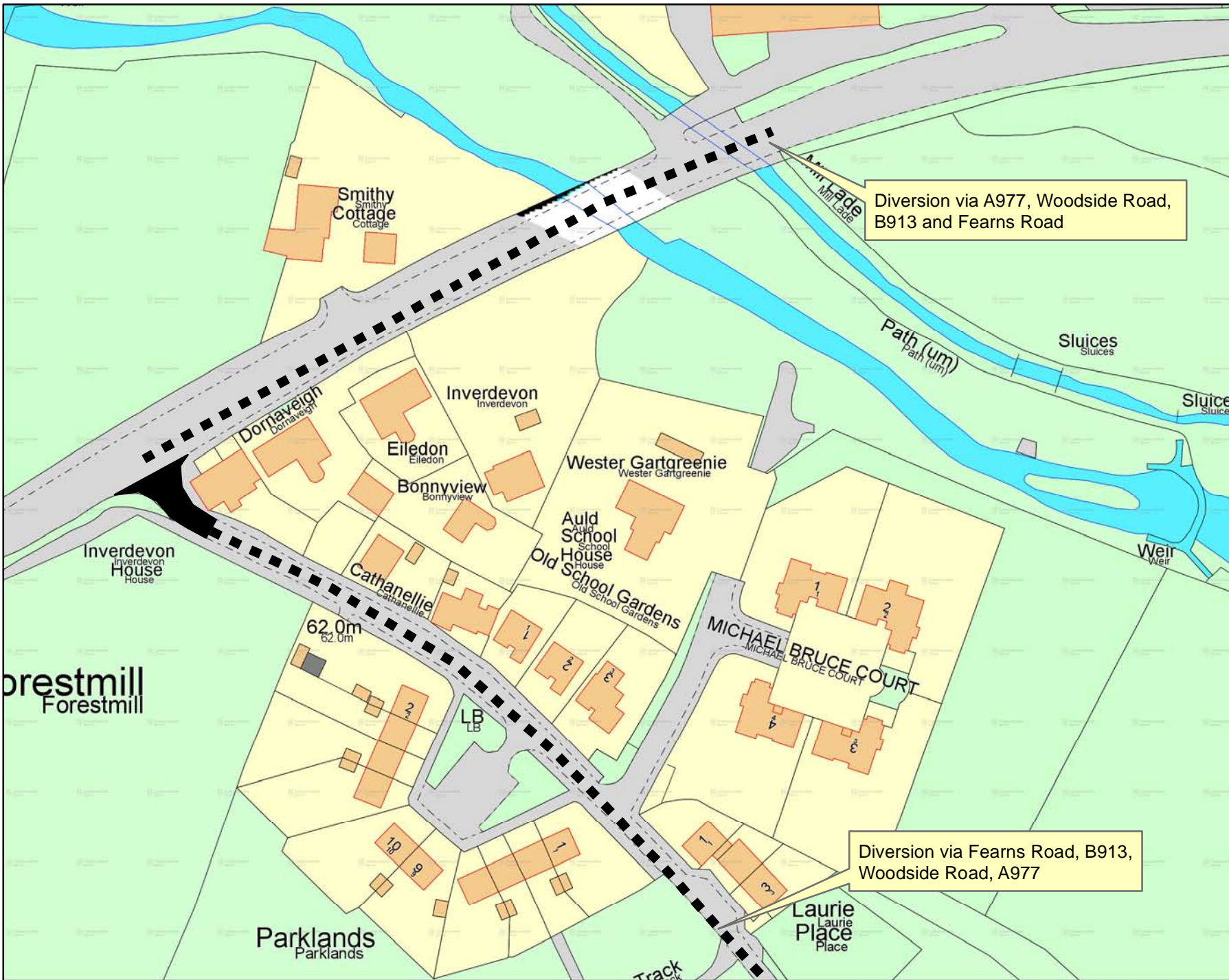

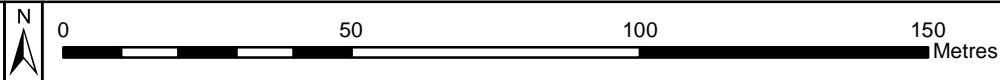
 Road Closure
