

# (LUDGATE, ALLOA) (TEMPORARY PARKING SUSPENSION) ORDER 2016

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Ludgate, Alloa) (Temporary Parking Suspension) Order 2016" and notwithstanding the date hereof shall come into operation on the 1<sup>st</sup> June 2016.
- 2. The effect of this Order shall be to suspend parking:The period from 0800 hours on Monday 13<sup>th</sup> June 2016 until 1700 hours on Friday 24<sup>th</sup> June 2016 on the section described in the Schedule attached. The temporary parking suspension is required to allow for footway resurfacing and kerbing works to take place and for safety of the workforce.
